WHEREAS, currently, the first-step salary rates for the Community Services Aide I, Library Page, Park Services Aide I and Student Intern classifications fall below the new State minimum wage; and

WHEREAS, a salary adjustment to the Community Service Aide II is recommended to prevent compaction with the Community Service Aide I classification; and

WHEREAS, the actions require the Personnel Policies and Practices Resolution No. 98-394 Appendix A be amended;

NOW, THEREFORE, BE IT RESOLVED THAT, the Board of Supervisors in and for the County of Monterey as follows:

1.
