RENEWAL AND AMENDMENT NO. 2 OF AGREEMENT BETWEEN THE COUNTY OF MONTEREY &

B&T Service Station Contractors

THIS AMENDMENT NO. 2 to the Agreement between the County of Monterey, a political subdivision of the State of California, hereinafter referred to as "COUNTY", and B&T Service Station Contractors, hereinafter "CONTRACTOR", is hereby entered into between the COUNTY and the CONTRACTOR, collectively the "Parties", and effective as of the last date opposite the respective signatures below.

WHEREAS, CONTRACTOR entered into an Agreement with COUNTY on January 9, 2020, hereinafter "Agreement", to provide new fuel pump dispensers and POS system for the Track and Paddock at WeatherTech Raceway Laguna Seca through December 31, 2020, for an amount not to exceed \$100,000; and

WHEREAS, Amendment No. 1 was made to the Agreement because the project was not completed by December 31, 2020; and

WHEREAS, COUNTY has a need to extend the warranty and service dates on the equipment provided by B&T; and

WHEREAS, additional funding is not necessary; and

WHEREAS, the Parties wish to amend the Agreement to extend the date through December 31, 2021 to allow COUNTY to purchase an extended warranty on the fuel pump dispensers and POS system and provide additional funding for potential repairs not covered by the extended warranty.

NOW, THEREFORE, the Parties agree to amend the Agreement as follows:

- 1. Amend paragraph 3.01 to read as follows: The term of this Agreement is from January 1, 2020 to December 31, 2021, unless sooner terminated pursuant to the terms of this Agreement. This Agreement is of no force or effect until signed by both CONTRACTOR and County and with County signing last, and CONTRACTOR may not commence work before County signs this Agreement.
- 2. Except as provided herein, all remaining terms, conditions and provisions of the AGREEMENT are unchanged and unaffected by this AMENDMENT and shall continue in full force and effect as set forth in the AGREEMENT.
- 3. A copy of the AMENDMENT #2 shall be attached to the original AGREEMENT signed January 9, 2020.
