**WHEREAS, Dorothy Maras-Ildiz** in 1982, sold her restaurants and relocated to the Monterey Peninsula taking on a position with Round Table Pizza Company and holding the titles of General Manager, Multi-Unit Manager, and Franchisee during her tenure; and

**WHEREAS, Dorothy Maras-Ildiz** in 1992, took the quantum leap to the fine dining arena managing the well-regarded and award winning Old Bath House Restaurant at Lovers Point in Pacific Grove; and

**WHEREAS, Dorothy Maras-Ildiz** serves as the Culinary Liaison for Coastal Luxury Management, which keeps her very busy coordinating the needs and requests of the multitude of chefs who participate in the Pebble Beach and Los Angeles Food & Wine events; and
