WHEREAS, the Aromas Water District (the "District"), a county water district duly organized and operating in the County of Monterey, is beginning special assessment proceedings under the Municipal Improvement Act of 1913 (Division 12 of the California Streets and Highways Code) (the "Act"), in and for the District's proposed Assessment District No. 2012-1 (the "Assessment District") for the construction and acquisition of water system improvements consisting, generally, of water supply, storage, treatment and distribution facilities for domestic and fire protection uses; and

WHEREAS, under Section 10104 of the Act, the District must obtain certain approvals from this Board of Supervisors as a condition to undertaking proceedings for the Assessment District; and

WHEREAS, the Secretary of the District has filed with the Clerk of this Board of Supervisors a copy of a resolution of the Board of Directors of the District requesting this Board of Supervisors to approve the form of a Resolution of Intention to Make Acquisitions and Improvements (the "Resolution of Intention"), and a Map of Proposed Boundaries of the Assessment District (the "Boundary Map") to be used by the District in its proceedings for the Assessment District, together with copies of the form of the District's proposed Resolution of Intention and Boundary Map; and

WHEREAS, the public interest, convenience and necessity will be served by the water system improvements to be financed by the Assessment District; and

WHEREAS, on March 27, 2012, the Board of Supervisors, acting as a responsible agency pursuant to the California Environmental Quality Ac, considered the Mitigated Negative Declaration certified by the District in connection with the project, and found that there was no substantial evidence that the project would have a significant effect on the environment with implementation of mitigation measures;

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of Monterey as follows:

- 1. The forms of the proposed Resolution of Intention and Boundary Map for the Assessment District submitted by the District to this Board of Supervisors are hereby approved;
- 2. The approvals granted herein shall not subject this County to any liability for the costs of the proposed water system improvements, the assessments to be levied on the property within the Assessment District, or any of the bonds or other evidences of indebtedness to be issued by the District for the Assessment District; and

3. The Clerk of this Board is directed to file a certified copy of this Resolution with the Secretary of the District as soon as possible.
