WHEREAS, the California Streets and Highway Code, Section 2121, requires counties to submit to the California Department of Transportation in May of each year, any additions, or exclusions from its mileage of maintained County roads, specifying the termini and mileage of each route added and excluded; and

WHEREAS, the California Department of Transportation certified to the State Controller in the year 2024 that the total mileage of County of Monterey maintained roads was 1,262.95 miles; and

WHEREAS, the Board now finds for 2025 the total mileage of County of Monterey maintained roads is 1,262.95 miles in accordance with the additions, exclusions or corrections to the tabulation as indicated in EXHIBIT 1 - SUMMARY SHEET 2025 MILEAGE OF MAINTAINED COUNTY ROADS COUNTY OF MONTEREY for the year 2025, attached hereto and incorporated by this reference as a part of this resolution; and

NOW THEREFORE, BE IT RESOLVED THAT, the Board of Supervisors of the County of Monterey hereby:

1. Approves the 2025 Annual Report of the mileage of the maintained County roads; and
2. Authorizes the Director of Public Works, Facilities and Parks to submit this Resolution with Exhibit 1 and any corresponding maps and tabulations to the California Department of Transportation.


