

**AMENDMENT #1 TO AGREEMENT BY AND BETWEEN
COUNTY OF MONTEREY & SALINAS VALLEY FORD SALES, INC.
dba SALINAS COLLISION REPAIR**

THIS AMENDMENT is made to the PROFESSIONAL SERVICES AGREEMENT for the provision of auto body repair services by and between SALINAS VALLEY FORD SALES, INC. dba SALINAS COLLISION REPAIR, hereinafter "CONTRACTOR", and the County of Monterey, a political subdivision of the State of California, hereinafter referred to as "County".

WHEREAS, the County and CONTRACTOR wish to amend the AGREEMENT to reflect the County's exercise of the option to extend for one (1) additional year.

NOW THEREFORE, the County and CONTRACTOR hereby agree to amend the AGREEMENT in the following manner:

1. **Section 3.1, "TERM OF AGREEMENT", shall be amended by removing** "The initial term shall commence with the signing of the AGREEMENT through and including August 31, 2015, with the option to extend the AGREEMENT for two (2) additional one (1) year periods. County is not required to state a reason if it elects not to renew this AGREEMENT.", **and replacing it with** "The initial term shall commence with the signing of the AGREEMENT through and including August 31, 2016, with the option to extend the AGREEMENT for one (1) additional one (1) year period. County is not required to state a reason if it elects not to renew this AGREEMENT".
2. Except as provided herein, all remaining terms, conditions and provisions of the AGREEMENT are unchanged and unaffected by this AMENDMENT and shall continue in full force and effect as set forth in the AGREEMENT.
3. A copy of this AMENDMENT shall be attached to the original AGREEMENT dated June 10, 2013.
