**AMENDMENT #3 TO AGREEMENT A-14667 BY AND BETWEEN COUNTY OF
MONTEREY & URETSKY SECURITY**

THIS AMENDMENT is made to the AGREEMENT for pre-employment background investigation services by and between **URETSKY SECURITY**, hereinafter "CONTRACTOR", and the County of Monterey, a political subdivision of the State of California, hereinafter referred to as "County".

WHEREAS, the County and CONTRACTOR originally entered into this Agreement on September 23, 2018 with a Not to Exceed amount of \$99,000 and a term date ending on September 22, 2020; and

WHEREAS, the County and CONTRACTOR amended the AGREEMENT by \$151,000 for a new Not to Exceed total of \$250,000 and extend the agreement by two (2) years, with a new term date ending on September 22, 2022; and

WHEREAS, the County and CONTRACTOR amended the AGREEMENT on November 30, 2020, by adding \$85,000 for a new Not to Exceed total of \$335,000.

WHEREAS, the County and CONTRACTOR wish to further amend the AGREEMENT by adding \$273,000 for a new Not to Exceed total of \$608,000 and extending the agreement with a new term ending date of September 22, 2023.

NOW THEREFORE, the County and CONTRACTOR hereby agree to amend the AGREEMENT in the following manner:

1. Section 2., "PAYMENT PROVISIONS" shall be amended by removing, "*The total amount payable by County to CONTRACTOR under this Agreement is not to exceed the sum of \$335,000.00*", and replacing it with, "*The total amount payable by County to CONTRACTOR under this Agreement is not to exceed the sum of \$608,000.00*".
2. Except as provided herein, all remaining terms, conditions and provisions of the AGREEMENT are unchanged and unaffected by this AMENDMENT and shall continue in full force and effect as set forth in the AGREEMENT.
3. A copy of the AMENDMENT shall be attached to the original AGREEMENT executed by the County on November 18, 2018.
