

**AMENDMENT NO. 1 TO AGREEMENT BY AND
BETWEEN COUNTY OF MONTEREY AND I-SIGHT**

THIS AMENDMENT NO. 1 to Agreement No. A-13724 between the County of Monterey, a political subdivision of the State of California (hereinafter, "County") and **i-Sight** (hereinafter, "CONTRACTOR") is hereby entered into between the County and the CONTRACTOR (collectively, the "Parties") and effective as of the last date opposite the respective signatures below.

WHEREAS, CONTRACTOR entered into Agreement No. A-13724 with County on September 18, 2017 (hereinafter, "Agreement") to provide Case Management Software services (hereinafter, "services") for the period of August 31, 2017 to August 31, 2020 for an amount not to exceed \$22,500; and

WHEREAS, County has a continued need for services; and

WHEREAS, additional time is necessary to allow CONTRACTOR to continue to provide the services required by the County; and

WHEREAS, the Parties wish to amend the Agreement to extend the term for three (3) additional years and increase the amount by \$25,000 for a total amount not to exceed \$47,500 to allow CONTRACTOR to continue to provide services identified in the Agreement as amended by this Amendment No. 1.

NOW THEREFORE, the Parties agree to amend the Agreement as follows:

1. Amend Paragraph 2, "Payments by County", to read as follows:

County shall pay the CONTRACTOR in accordance with the payment provisions set forth in Exhibit A, subject to the limitations set forth in this Agreement. The total amount payable by County to CONTRACTOR under this Agreement shall not exceed the sum of \$47,500.

2. Amend the first sentence of Paragraph 3, "Term of Agreement", to read as follows:

The term of this Agreement is from August 31, 2017 to August 30, 2023, unless sooner terminated pursuant to the terms of this Agreement. .


3. All other terms and conditions of the Agreement, including all Exhibits thereto, remain unchanged and in full force.
4. This Amendment No. 1 shall be attached to the Agreement and incorporated therein as if fully set forth in the Agreement.




