WHEREAS, on November 26, 1963, the Monterey County Board of Supervisors created County Service Area 25-Carmel Valley Golf & Country Club (CSA 25) and established county services for the CSA;

WHEREAS, at the request of CSA 25 property owners, the CSA 25 Advisory Committee (Committee) was formed on January 26, 2021;

WHEREAS, bylaws established a membership of five (5) regular members and three (3) alternates;

WHEREAS, there are four (4) separate developments within the CSA: Quail Lodge (a commercial development) and three residential developments: Homeowners at Quail, Inc, Quail Meadows, and Birchfield Condominium Association;

WHEREAS, current committee members representation on the Committee by three (3) property owners from Homeowners at Quail, Inc. plus one (1) alternate, one (1) property owner from Quail Meadows, and one (1) representative from Quail Lodge. There is no representation from the Birchfield Condominium Association;

WHEREAS, members of the Advisory Committee have requested an increase in member from five (5) members and three (3) alternatives to allow for representation from Birchfield Condominium Association:

WHEREAS, the CSA budget includes funding for staff time to prepare for an attend CSA Advisory Committee Meetings and no additional financial impacts will result from this bylaw modification;

NOW, THEREFORE, BE IT RESOLVED THAT the Monterey County Board of Supervisors, acting as the Board of Directors of CSA 25, hereby adopts the following modifications to Section 2 of the CSA 25 Advisory Committee By-Laws:

Section 2. MEMBERSHIP AND MEMBERSHIP QUALIFICATIONS

The Committee shall consist of six (6) members and three (3) alternates appointed by the Monterey County Board of Supervisors, acting as the Board of Directors of CSA 25. These members shall be representatives of the area within the jurisdictional boundaries of CSA 25. Members shall be residents of the County of Monterey and reside within the CSA 25 Area. An alternate shall fill the position of a member when a member is unavailable for one (1) or more meetings.
