

**AMENDMENT NO. 3 TO AGREEMENT  
BY AND BETWEEN  
COUNTY OF MONTEREY AND  
QLIQSOFT, INC.**

**THIS AMENDMENT NO. 2** to Agreement No. A-14293 (“Agreement”) for Qliq Secure texting service subscription, by and between QliqSoft, Inc., (hereinafter referred to as “CONTRACTOR”), and the County of Monterey, a political subdivision of the State of California, (hereinafter referred to as “COUNTY”) with respect to the following.

**WHEREAS**, on May 2, 2019, COUNTY and CONTRACTOR entered into AGREEMENT No. A-14293 in the amount of \$21,600, with a term of April 1, 2019, through March 31, 2022; and

**WHEREAS**, COUNTY and CONTRACTOR entered into AMENDMENT NO. 1 to said AGREEMENT to replace Exhibit A and increase the total amount of the Agreement to cover added services; and

**WHEREAS**, on March 31, 2022, AGREEMENT A-14293 expired by its terms; and

**WHEREAS**, COUNTY and CONTRACTOR wish to renew and amend AGREEMENT A-14293 retroactive to April 1, 2022; and

**WHEREAS**, this RENEWAL and AMENDMENT NO. 2 is necessary due to COUNTY’S continued need for CONTRACTOR’S services; and

**WHEREAS**, the COUNTY and CONTRACTOR entered AMENDMENT NO. 2 to increase the total amount of the Agreement, replace Exhibit A, and to extend the term of the Agreement for three (3) additional years; and

**WHEREAS**, the COUNTY and CONTRACTOR wish to amend the AGREEMENT to increase the total amount of the Agreement by \$200,000 for a new total Agreement amount of \$476,504, replace Exhibit A, and to extend the term of the Agreement for three (3) additional years for a new term of April 1, 2019, through March 31, 2028; and

**NOW THEREFORE**, the County and CONTRACTOR hereby agree as follows:

- 1. Paragraph 2, under Section 2. “Provision of Service.”** shall be removed and replaced with, “QliqSOFT shall make the Service available to Customer pursuant to the terms and conditions set forth in this Agreement and as specified in Exhibit A-3 hereto. During the term of this Agreement, the Service shall perform materially in accordance with Exhibit A-3 hereto.”
- 2. Paragraph 4, under Section 4.1 “User Fees.”** shall be removed and replaced with, “Customer shall pay all fees specified in Exhibit A-3 hereto. Subscription fees are based on the number of users in the Customer’s group, not the extent of actual usage. Except as otherwise provided, fees are non-refundable, and the number of subscriptions purchased cannot be decreased after the beginning of each subscription term stated in Exhibit A-3, except in accordance with the

terms of cancellation provided in this Agreement. The subscription charges at the beginning of each quarter will be based upon the then current number of users.”

3. **Paragraph 4, under Section 4.2 “Invoicing and Payment.”** shall be removed and replaced with, “Fees for the Service will be invoiced in advance and otherwise in accordance with the terms set forth in Exhibit A-3.”
4. **Exhibit A-3: QliqSOFT Subscription Services** replaces Exhibit A-2. All references in the Agreement to Exhibit A shall be construed to refer to Exhibit A-3.
5. This Amendment No. 3 is effective upon execution.
6. Except as provided herein, all remaining terms, conditions and provisions of the Agreement are unchanged and unaffected by this Amendment No. 3 and shall continue in full force and effect as set forth in the Agreement.
7. A copy of this Amendment No. 3 shall be attached to the original AGREEMENT dated May 2, 2019.

This is an amendment to the QliqSOFT Secure Texting Service Subscription Agreement between QliqSOFT, Inc and County of Monterey, a political subdivision of the State of Colorado executed on 4/1/2019. This amendment will replace Exhibit A on the original agreement.

**Subscription:**

Customer agrees to purchase and QliqSOFT agrees to provide one private group of the QliqCHAT Secure Texting Service. The Service shall begin on **April 1, 2025**, and continue for **three (3) years**, for a revised full term of April 1, 2019 – March 31, 2028 and a revised total Agreement amount of \$476,504.

**Subscription Fees:** Customer agrees to pay subscription fees in accordance to the fee schedule and payment terms below.
