AMENDMENT #1 TO SERVICE AGREEMENT By & Between COUNTY OF MONTEREY & VAL'S PLUMBING AND HEATING, INC.

- 1. Section 4.0, Subsection 4.1, Compensation and Payments, shall be amended by adding: "The annual aggregate is not to exceed \$100,000 and the per project cost is not to exceed \$10,000 upon date of execution of Amendment No. 1 through the term end."
- 2. Except as provided herein, all remaining terms, conditions, and provisions of the AGREEMENT are unchanged and unaffected by this AMENDMENT and shall continue in full force and effect as set forth in the AGREEMENT.
- 3. A copy of the AMENDMENT shall be attached to the original AGREEMENT dated January 23, 2014.
