

**AMENDMENT No. 2 TO PARTICIPATING AGREEMENT
COUNTY OF MONTEREY & Gila LLC, dba Municipal Services Bureau (MSB)**

THIS AMENDMENT No. 2 is made to the Participating Agreement by and between Gila LLC, dba Municipal Services Bureau (MSB), hereinafter “CONTRACTOR”, AND The County of Monterey, a political subdivision of the State of California, hereinafter referred to as “COUNTY” for collection services as per Master Agreement (MA-201307 Amendment No. 2) with the Judicial Council of California.

WHEREAS, the COUNTY and CONTRACTOR had previously entered into a Participating Agreement, with a term of May 1, 2014 through April 30, 2016.

WHEREAS, the COUNTY and CONTRACTOR extended the agreement per Amendment No.1, with a term of May 1, 2016 through April 30, 2017

WHEREAS, the COUNTY and CONTRACTOR wish to acknowledge and incorporate the terms and conditions of the Judicial Council of California MA-201307 Amendment No. 2, dated December 19, 2016, attached hereto as Attachment A into the **Participating Agreement** whereby the term has been extended for one additional year.

WHEREAS, the parties desire to amend that Participating Agreement to reflect the County’s exercise of the option to extend the term, on the same or similar terms, for the period of May 1, 2017 through April 30, 2018.

NOW THEREFORE, the County and CONTRACTOR hereby agree as follows:

1. The **PARTICIPATING AGREEMENT** between COUNTY and CONTRACTOR is hereby amended and extended to include the period of May 1, 2017 through April 30, 2018, unless sooner terminated pursuant to the terms of the **PARTICIPATING AGREEMENT** or extended in writing by parties.
2. The terms and conditions of the Judicial Council of California MA-201307 Amendment No. 2, dated December 19, 2016, attached hereto as Attachment A into the **PARTICIPATING AGREEMENT**.
3. If there is any conflict or inconsistency between the provisions of the **PARTICIPATING AGREEMENT**, or this **AMENDMENT**, the provisions of this **AMENDMENT** shall govern. A copy of the **AMENDMENT** shall be attached to the original **PARTICIPATING AGREEMENT**, as it may have been previously amended. Except as provided herein, all remaining terms, conditions, provisions, entitlements and obligations of the original **PARTICIPATING AGREEMENT** shall remain unchanged and unaffected by this **AMENDMENT** and shall continue in full force and effect.




