

**ADDENDUM TO MEMORANDUM OF UNDERSTANDING**  
**BETWEEN**  
**THE NORTH MONTEREY COUNTY UNIFIED SCHOOL DISTRICT**  
**AND**  
**THE MONTEREY COUNTY SHERIFF'S OFFICE**  
**FOR**  
**SCHOOL RESOURCE OFFICER SERVICES**

This Addendum to the Memorandum of Understanding ("MOU Agreement") is made and entered into by and between the North Monterey County Unified School District ("NMCUSD" or "District") and the Monterey County Sheriff's Office ("County") effective January 1, 2017. This addendum clarifies the payment terms that have been modified to the original MOU Agreement to reflect the late start of the implementation of the agreement.

TERM: The MOU Agreement has been modified to reflect the term from January 1, 2017 through June 30, 2017.

PAYMENT AMOUNT AND SCHEDULE: The payment amount will be modified to reflect services for 50% (fifty percent) of the Fiscal Year: January 1, 2017 through June 30, 2017. The total amount NMCUSD will contribute will not exceed \$48,493.50 (which is fifty percent of the original agreement of \$96,987 for a whole fiscal year of service) for services from January 1, 2017 through June 30, 2017. The County will invoice NMCUSD up to four times with the last invoice to be received by NMCUSD no later than July 15, 2017 for final payment. (Refer to Section 7 and Section 8 in original MOU Agreement).

SRO SCHEDULE: The School Resource Office (SRO) will begin services no later than January 9, 2017, the first school day in January 2017. The SRO will work each scheduled school day beginning January 9, 2017 through June 9, 2017. The tentative workday schedule will be from 7:30 AM to 3:30 PM, Monday through Friday with modification made to the schedule for non-school days. (Refer to Section 3 in original MOU Agreement).

Non-school days are:


- January 16, 2017 (Holiday-MLK Day)
- January 27, 2017 (Staff Professional Development Day)
- February 17, 2017 (Holiday-Lincoln's Birthday)
- February 20, 2017 (Holiday-President's Day)
- March 10, 2017 (Staff Professional Development Day)
- **March 20-March 24, 2017 (Spring Break)**
- April 14, 2017 (No school)
- April 17, 2017 (Floating Holiday)
- May 26, 2017 (No School)
- May 29, 2017 (Holiday-Memorial Day)

- *June 12-June 20, 2017 (Summer Break)*

The SRO is expected to attend trainings and conferences related to serving at the SRO. For example, there is a SRO Basic Course offered by the National Association of School Resource Officers the week of June 19-June 23, 2017 in Chandler AZ. This would be considered part of the SRO's expected schedule, in addition to other required trainings and scheduled vacation time or other leave time all of which is highly encouraged to be taken during non-school days. (Refer to Section 3 in original MOU).

All other terms are outlined in the original MOU Agreement that this Addendum is attached to.
