3. Provide a brief description of the goods/services to be purchased and why this purchase is being proposed under a sole source acquisition.

Yearly maintenance service, technical support and system upgrades of the County's Mitel phone system

a) Why were product and/or vendor chosen?

The County has an extensive, existing telephone system that provides voice communications services to many County Departments.

It is essential to utilize this vendor that assisted in the design and ongoing maintenance/support and upgrades to the phone system to ensure continuity of service to the county.

- b) What are the unique performance features of the product/brand requested that are not available in any other product/brand? For Services: what unique qualifications, rights, and licenses does the vendor possess to qualify as a sole source/brand request?

There are no unique performance features of the product other than the current system has an installed value of over 5 million dollars, changing the system would not be feasible at this time.

Considering another vendor would not be cost effective to the county and to the stability of the telecommunications network as the new vendor would need to perform a full assessment and evaluation of the system before providing the technical support/maintenance and/or warranty extension. This would not be in the best interest of the county and could pose a risk to the quality for service during the evaluation and assessment by a new vendor. The complexity of the telecommunications network spanning the county coupled with the reliable services/support provided by this vendor justifies the sole source.

- c) Why are these specific features/qualifications required?

The vendor must be a licensed Mitel distributor.

- d) What other products/services have been examined and/or rejected?

None at this time.

- e) Why are other sources providing like goods or services unacceptable (please give a full meaningful explanation)?

This vendor has a history of providing, and is currently under agreement to provide maintenance and support to all of the County Mitel telephone equipment.

f) What are the unique performance features REQUIRED (not merely preferred), and how would your requirement be inhibited without this particular item or service?

There are no unique performance features required.






