**AMENDMENT NO. 1
TO STANDARD AGREEMENT
COUNTY OF MONTEREY
AND
NORCAL RENTAL GROUP LLC dba CRESCO EQUIPMENT RENTALS**

THIS AMENDMENT NO. 1 (Amendment) is made to the Standard Agreement between the County of Monterey, a political subdivision of the State of California ("County") and Norcal Rental Group LLC dba Cresco Equipment Rentals (hereinafter, "Contractor") (collectively, the "Parties") and effective as of the last date opposite the respective signatures below.

WHEREAS, the Parties entered into a **Standard Agreement** on April 17, 2023 (the "Agreement") to allow Contractor to provide Golf Cart Rentals and Services (the "Services"); and

WHEREAS, the Parties wish to amend the Agreement to extend the Agreement Term and increase the not to exceed sum; and

NOW, THEREFORE, the Parties agree to amend the Agreement as follows:

1. Section 2.0, "Payment Provisions" is deleted in its entirety and replaced with "County shall pay the CONTRACTOR in accordance set forth in this Agreement. The total amount payable by County to CONTRACTOR under this Agreement shall not exceed the sum of \$325,000".
2. Section 3.0, "Term of Agreement, sub-section 3.01" is deleted in its entirety and replaced with:
"The term of this Agreement is from April 1, 2023 to December 31, 2024, unless sooner terminated pursuant to the terms of this Agreement. This Agreement is of no force or effect until signed by both Contractor and County and with County signing last, and Contractor may not commence work before County signs this Agreement".
3. Exhibit A, Section A1.2.3.1 is amended to include the 2024 events as follows:
