RE: NOTICE OF AMENDED FINAL GRANT AWARD - BEHAVIORAL HEALTH CONTINUUM INFRASTRUCTURE PROGRAM (BHCIP) ROUND 5: CRISIS AND BEHAVIORAL HEALTH CONTINUUM

Dear Elsa M. Jimenez, MPA:

The Department of Health Care Services (DHCS) is pleased to inform the County of Monterey of your final award announcement in the amount of \$20,166,779.00 for completion of the Monterey County Regional MHRC project as represented in your BHCIP Round 5: Crisis and Behavioral Health Continuum grant application and approved project budget. In addition, DHCS has approved the following project amendment(s), while all other project details initially approved remain unchanged:

- Project location change from 1420 Natividad Road, Salinas, California 93906 to Constitution Blvd and Medical Center Dr., Salinas, California 93906
- Change to APN/Parcel Number from 003-851-035 to 003-851-039
- Decrease bed count for Mental Health Rehabilitation Center (MHRC) from 100 beds to 96 beds
- Increase project square footage from 40,000 square feet to 60,000 square feet
- Budget changes as described in submitted revised budget

Receipt of BHCIP grant funding is contingent upon review and final execution of the required Program Funding Agreement (PFA) with Advocates for Human Potential (AHP), BHCIP's administrative entity. AHP will provide you with an amended PFA within a few days from the date of this notice. The PFA has been carefully drafted to address DHCS' and AHP's compliance needs.

As the BHCIP grant awardee, you are solely responsible for any costs to complete the project in excess of the program funds award amount. DHCS will not be responsible for any cost overruns.

DHCS discourages any project change that impacts deadlines and the overall BHCIP project schedule. If for any reason acceptance of the BHCIP Round 5: Crisis and Behavioral Health Continuum funding proves problematic in that you are unable to execute the Program Funding Agreement, your project is no longer reflective of the project described in your application and supporting documentation for funding, there is concern about the perpetuity of your BHCIP project, or you are no longer interested in receiving funding, please contact DHCS/AHP immediately.

DHCS is excited to embark on this endeavor with you to expand the continuum of behavioral health facilities in California. We are doing lasting work that will benefit some of our state's most vulnerable individuals.
