Resolution recognizing *Community Foundation of Santa Cruz* County as the Santa Cruz County Farm Bureau's 2016 Al Smith Friend of Agriculture Award Recipient.....)

WHEREAS, the Al Smith Friend of Agriculture Award is presented each year by the Santa Cruz County Farm Bureau. The award, named for the founder of Orchard Supply Hardware, is given to an individual or group who has contributed significantly to the agricultural industry, but is not in production agriculture. The recipient of the 2016 Al Smith Friend of Agriculture Award is *COMMUNITY FOUNDATION OF SANTA CRUZ*; and,

WHEREAS, Community Foundation of Santa Cruz County was established in 1982 as a result of a group of individuals wanting to have a central location for donations to assist with the flood damage that occurred in the county that was deemed a natural disaster; and,

WHEREAS, Community Foundation of Santa Cruz County promotes philanthropy to make Santa Cruz a better place to love; now and in the future; and,

WHEREAS, *Community Foundation of Santa Cruz County* has funded programs such as: Salud Para La Gente, Agri-Culture, Action Pajaro Valley, Live Earth Farms Discovery Program, Agriculture History Project, Community Alliance for Family Farmers and the Pajaro Valley Community Health Trust; and,

WHEREAS, *Community Foundation of Santa Cruz County* is a partner of Driscoll's philanthropy program acting as the "back office" for more than \$6.5 million in charitable distributions since 2002; and,

WHEREAS, to date *Community Foundation of Santa Cruz County* has granted over \$94 million in grants; and,

WHEREAS, Community Foundation of Santa Cruz County's assets are now over \$100 million. The largest gift was \$30+ million from the legacy of the Borina farming family.
