

**FIRST AMENDMENT TO AGREEMENT
FOR ACUTE PSYCHIATRIC INPATIENT HOSPITAL SERVICES BETWEEN THE
COUNTY OF SANTA CLARA, MONTEREY COUNTY
NATIVIDAD MEDICAL CENTER, AND
MONTEREY COUNTY HEALTH DEPARTMENT – BEHAVIORAL HEALTH BUREAU
FOR HOSPITAL SERVICES**

This Amendment (Amendment) to the Agreement (“Agreement”) between the County of Santa Clara (“CSC”) and the County of Monterey (“MC”) on behalf of the Health Department – Behavioral Health Bureau (“BHB”) and Natividad Medical Center (“NMC”) for the provision of Psychiatric Inpatient Hospital Services beginning February 1, 2013 through June 30, 2014 is hereby amended effective July 1, 2014.

ARTICLE 4, TERMINATION, DELEGATIONS, OR ASSIGNMENT, Section 4.1 Term is replaced in its entirety to extend the Term as follows:

This agreement will commence on February 1, 2013, (“Effective Date”) and expire on June 30, 2015, unless earlier terminated or extended. This Agreement will become ineffective, at such time as CSC is no longer designated by the DMH as a Mental Health Plan to provide Psychiatric Inpatient Hospital Services in accordance with Section 5775, Subdivision (a), of the California Welfare and Institutions Code and the Regulations.

Except as set forth herein, all other terms and conditions of the Agreement shall remain in full force and effect, provided, however, in the event of any conflict between the terms of this FIRST Amendment and the Agreement, the terms of this FIRST Amendment shall control.
