- Oversaw the performance of approximately forty-five employees in a variety of professional and skilled labor classes

- Managed 25 staff from Senior Engineers to Water Maintenance Workers to operate and maintain facilities owned by MCWRA, including two large earthen dams, a hydroelectric power plant, a low head diversion facility, several drainage pump stations, miles of drainage channels, and the Pajaro River Levee
- Prepared annual budgets, three-year budget estimates, and approved expenditures of approximately \$10-25M annually
- Work closely and strategically with Regulatory and Partner Agencies
