WHEREAS, Natividad Medical Center (NMC) administration staff recently conducted a classification and base wage study to determine if there is sufficient market data to support the creation of a trauma registry position with a market aligned salary to ensure ongoing compliance with the American College of Surgeons requirements to maintain NMC's trauma designation; and

WHEREAS, the study found that there was sufficient market data available to support the creation of a Trauma Registrar classification; and

WHEREAS, to establish a salary for this new classification, NMC completed an external base wage compensation analysis and found there were two (2) of the six (6) hospital comparable agencies and a review of internal classifications was performed to ensure internal alignment; and

WHEREAS, NMC also recommends the addition of a Management Analyst II position and the reallocation of two (2) Administrative Services Assistant positions and one (1) Health Information Management Coder II position to three (3) Trauma Registrar positions; and

WHEREAS, to implement the recommendations, these actions require that both the Personnel Policies and Practices Resolution No. 98- 394 Appendices A and B and the FY 2024-25 NMC Adopted Budget be amended;

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors in and for the County of Monterey as follows:
