

AMENDMENT #3 TO AGREEMENT BY AND BETWEEN COUNTY OF MONTEREY and CHMURA ECONOMICS & ANALYTICS, LLC

THIS AMENDMENT is made to the PROFESSIONAL SERVICES AGREEMENT for the provision of a JobsEQ® labor market software license subscription, by and between CHMURA ECONOMICS & ANALYTICS, LLC, hereinafter “CONTRACTOR”, and the County of Monterey, a political subdivision of the State of California, hereinafter referred to as “County”.

WHEREAS, on April 1, 2016, the County and CONTRACTOR amended the AGREEMENT, pursuant to Amendment Number 1, to increase funding and extend the term for an additional year; and

WHEREAS, on July 13, 2017, the County and CONTRACTOR amended the Agreement, pursuant to Amendment Number 2, in order to increase funding and extend terms for an additional year and to update notice and contact information.

WHEREAS, the County and CONTRACTOR wish to again amend the AGREEMENT to reflect the County’s exercise of the option to extend the AGREEMENT for one (1) additional year; and

NOW THEREFORE, the County and CONTRACTOR hereby agree to amend the AGREEMENT in the following manner:

1. Paragraph 2.0, “PAYMENT PROVISIONS,” shall be amended by removing the amended language “The total amount payable by County to CONTRACTOR under this Agreement is not to exceed the sum of \$14,985” and replacing it with “*The total amount payable by County to CONTRACTOR under this Agreement is not to exceed the sum of \$19,980.*”
2. Paragraph 3, “TERM OF AGREEMENT,” shall be amended by removing the amended language “The term of this Agreement is from April 1, 2016 to March 31, 2019, unless sooner terminated pursuant to the terms of this Agreement”, and replacing it with “*The term of this Agreement is from April 1, 2016 to March 31, 2020, unless sooner terminated pursuant to the terms of this Agreement.*”
3. Except as provided herein, all remaining terms, conditions and provisions of the AGREEMENT, as amended, are unchanged and unaffected by this AMENDMENT and shall continue in full force and effect as set forth in the AGREEMENT.
4. A copy of this AMENDMENT shall be attached to the original AGREEMENT dated April 1, 2016 and Amendment No. 2.
