WHEREAS, the MOU became effective as of January 23, 2012, to expire on January 22, 2013, unless extended by the parties; and,

WHEREAS, the parties extended the MOU for a two-year period, to expire in January of 2015; and,

WHEREAS, the parties further extended the MOU for an addition two-year period in December of 2014, to expire on January 5, 2017; and,

WHEREAS, the parties desire to further extend the MOU for a third two-year period, to expire on January 31, 2019; NOW, THEREFORE,

BE IT RESOLVED, by the Board of Supervisors in and for the County of Monterey that the Monterey County Sheriff is hereby authorized to execute for and on behalf of the County of Monterey the third amendment to the MOU attached hereto extending the term of the MOU until the close of business January 31, 2019.
