4. Consider receiving a report regarding the use of a Public Private Partnership for the Interlake Tunnel Project and Spillway Modification Project under Government Code Sections 5956 - 5956.10, the California Infrastructure Financing Act.

5. Consider the following in support of progress on the Interlake Tunnel and San Antonio Dam Spillway Modification Project (collectively, the “Projects”):

a. Approving a Third Reimbursement and Funding Agreement between the

County of Monterey and the Monterey County Water Resources Agency, in the amount of \$971,000 for (i) Environmental Consulting Services Phase I work; and, (ii) Program Management Services for the Projects; and,

- b. Approving a Professional Services Agreement with Horizon Water and Environment, LLC, in the amount of \$1.72 million, to provide environmental consulting services for the Projects; and, authorizing the Monterey County Water Resources Agency General Manager to execute the Agreement, substantially in the form of Agreement attached and subject to approval by County Counsel;
- c. Approving authorization to proceed with Phase I of the Environmental Consulting Services work.

- b. A Professional Services Agreement with Horizon Water and Environment, LLC, in the amount of \$1.72 million, to provide environmental consulting services for the Projects; and, authorize the Monterey County Water Resources Agency General Manager to execute the Agreement; and,
- c. Approved authorization to proceed with Phase I of the Environmental Consulting Services work. 4-0 (Supervisor Potter Absent)
