**AMENDMENT NO. 3  
TO SERVICES AGREEMENT  
BETWEEN GE Healthcare AND  
NATIVIDAD MEDICAL CENTER  
FOR  
Biomedical Services**

This Amendment No. 3 to the Services Agreement ("Agreement") which was effective on September 1, 2007 is entered into by and between the County of Monterey, on behalf of Natividad Medical Center (hereinafter "NMC"), and GE Healthcare (hereinafter "CONTRACTOR"); (collectively, the County, NMC and CONTRACTOR are referred to as the "Parties"), with respect to the following:

**RECITALS**

**WHEREAS**, the Agreement was executed for biomedical services with a term of September 1, 2007 to August 31, 2012 and a total Agreement amount not to exceed \$4,355,000; and

**WHEREAS**, NMC and CONTRACTOR amended the Agreement on March 1, 2009 via Renewal and Amendment No. 1 add an additional \$323,700 to fiscal year 2008-09, with no increase to the total Agreement amount not to exceed \$4,355,000 and no change to the Agreement term; and

**WHEREAS**, NMC and CONTRACTOR amended the Agreement on January 11, 2011 via Amendment No. 2 to reduce the total Agreement amount to a not to exceed of \$2,522,506 and revise the Agreement term end date to December 14, 2017; and

**WHEREAS**, NMC and CONTRACTOR currently wish to amend the Agreement adding an additional \$450,000 to allow for services to continue for a total Agreement amount of \$2,972,506 with no change to the term end date of December 14, 2017.

**AGREEMENT**

**NOW, THEREFORE**, the Parties agree to amend the Agreement as follows:

The Agreement is hereby renewed on the terms and conditions as set forth in the Original Agreement, Renewal and Amendment No 1, Amendment No. 2, and Amendment No. 3 incorporated herein by this reference, except as specifically set forth below.

1. The second sentence in Section 2 of the original Agreement, "PAYMENTS BY NMC" shall be amended to the following:  
*"The total amount payable by NMC to CONTRACTOR under this Agreement shall not exceed the total sum of \$2,972,506."*
2. Except as provided herein, all remaining terms, conditions and provisions of the Original Agreement are unchanged and unaffected by this Amendment No. 3 and shall continue in full force and effect as set forth in the Agreement, Renewal and Amendment No. 1 and Amendment No. 2.
3. A copy of this Amendment No. 3 shall be attached to the Original Agreement.
4. The effective date of this Amendment shall be January 1, 2017.
