

AMENDMENT #3 TO AGREEMENT

AMENDMENT #3 TO PROFESSIONAL SERVICES AGREEMENT COUNTY OF MONTEREY & KEY AND YOUNG, INC., DBA COMMERCIAL SERVICE COMPANY

THIS AMENDMENT is made to the AGREEMENT for repair and maintenance services on refrigeration, food preparation and food service equipment by and between KEY AND YOUNG, INC., DBA COMMERCIAL SERVICE COMPANY, hereinafter "CONTRACTOR", and the County of Monterey, a political subdivision of the State of California, hereinafter referred to as "County".

WHEREAS, the County and CONTRACTOR entered into the AGREEMENT on July 1st, 2014 and subsequently amended the AGREEMENT with Amendment #1 on October 14th, 2014 and with Amendment #2, on May 18th, 2016; and

WHEREAS, the County and CONTRACTOR wish to amend the AGREEMENT additional to extend its length, and to increase the total amount of the AGREEMENT due to the addition of time to the contract.

NOW THEREFORE, the County and CONTRACTOR hereby agree to amend the AGREEMENT in the following manner:

1. Section 2., "PAYMENTS BY THE COUNTY" shall be amended by removing, "*The total amount payable by County to CONTRACTOR under this Agreement shall not exceed the sum of \$90,000.*" and replacing it with "*The total amount payable by County to CONTRACTOR under this AGREEMENT shall not exceed the sum of \$140,000.*"
2. Section 3., "TERM OF AGREEMENT" shall be amended by removing, "*The term of the AGREEMENT is from July 1, 2014 to June 30, 2018*" and replacing it with, "*The term of the AGREEMENT is from July 1, 2014 to June 30, 2019*".
3. Except as provided herein, all remaining terms, conditions and provisions of the AGREEMENT are unchanged and unaffected by this AMENDMENT and shall continue in full force and effect as set forth in the AGREEMENT.
4. A copy of the AMENDMENT shall be attached to the original AGREEMENT executed by the County on July 1, 2014.
