WHEREAS, each year the American Culinary Federation, Monterey Bay Chapter, recognizes an esteemed Chef who has shown outstanding dedication to members of the ACF, the culinary industry, and the community with the prestigious "Chef of the Year" Award and the ACF, Monterey Bay Chapter’s 2019 “Chef of the Year” is **CHEF ESTEVAN JIMENEZ**; and

WHEREAS, as Executive Chef at Rancho Cielo **CHEF ESTEVAN JIMENEZ** oversees all the culinary education programs and acts as a mentor to underserved and disconnected youth—helping them find a path to future success. He also is responsible for meals served at special events and helps with fundraising; and

WHEREAS, **CHEF ESTEVAN JIMENEZ** has been active in the Monterey Bay Chapter of ACF, especially its education and scholarship programs, and he has generously volunteered his time for a variety of causes throughout Monterey County, including United Way, Salinas Rotary, Kinship Center, ASPCA, Meals on Wheels, the Artichoke Festival and the Community Christmas Dinner at the Monterey County Fairgrounds.
