BOARD OF SUPERVISORS RESOLUTION

Resolution No.: 26-132

Adopt a resolution proclaiming **May 2026** as “**Older Americans Month**” in Monterey County.....)

WHEREAS, The Older Americans Act, also known as the “Act”, was signed into law in 1965. It is recognized as the first federal initiative designed to provide comprehensive services for older adults. Subsequent reauthorizations have expanded and strengthened the scope and impact of the Act; and

WHEREAS, The Act serves as a vital vehicle for organizing, delivering and expanding social, nutritional, and essential services for older adults, individuals with disabilities, and their caregivers through the Area Agency on Aging and its network of service providers; and

WHEREAS, Despite increasing demand for services, aging and disability service networks continue to face challenges, including the absence of additional funding through the Act to support these services as costs continue to rise, impacting those who rely on essential services and supports; and

Whereas, AARP recognizes the County of Monterey as an official member of its “National Network of Age Friendly States and Communities,” supported by the Local Aging and Disability Action Plan, which aligns with the State of California’s “Master Plan for Aging,” a bold blueprint for all aging Californians; and

WHEREAS, The Area Agency on Aging and the Aging and Disability Resource Connection, together with community partners, have been diligently conducting outreach to older adults, individuals with disabilities, and caregivers to provide resources and information about healthy aging and to empower them in shaping their future; and


WHEREAS, The County of Monterey Board of Supervisors, also known as the “Board,” recognizes the 2026 **Older Americans Month** theme aligns with the Board’s Strategic Plan Goal: Well-Being and Quality of Life, which promotes safe and healthy communities and programs that support the health, independence, and well-being of older adults, individuals with disabilities, and caregivers through coordinated efforts across Monterey County; and




