RENEWAL AND AMENDMENT No. 1 TO SERVICES AGREEMENT BETWEEN Kasavan Architects AND NATIVIDAD MEDICAL CENTER FOR

ARCHITECTURAL SERVICES ON PROJECTS \$100,000 OR LESS AT NMC PER RFP #9600-25

This Renewal and Amendment No.1 to the Services Agreement ("Agreement"), dated November 1, 2012 is entered into by and between the County of Monterey, on behalf of Natividad Medical Center (hereinafter "NMC"), and Kasavan Architects (hereinafter "CONTRACTOR"), with respect to the following:

RECITALS

WHEREAS, NMC and CONTRACTOR had previously entered into an Agreement which was one of four agreements executed for Architectural Services per RFP 9600-25 with a one year term plus two (2) additional one (1) year options to extend, and an aggregate total for all Agreements not to exceed \$750,000 annually; and

WHEREAS, that Agreement expired on November 5, 2013; and

WHEREAS, the Deputy Purchasing Manager for NMC is authorized to execute two (2) future amendments to all contracts pursuant to Master Agreement RFQ 9600-25 where amendments do not exceed ten percent (10%) of the original Master Agreement; and

WHEREAS, NMC and CONTRACTOR currently wish to renew and amend the Agreement retroactive to November 6, 2013 and to extend it for an additional two (2) year period through November 5, 2015 to allow for services to continue as per the Agreement.

AGREEMENT

NOW, THEREFORE, the parties agree to amend the Agreement as follows:

The Agreement is hereby renewed on the terms and conditions as set forth in Original Agreement incorporated herein by this reference, except as specifically set forth below.

- 1. Except as provided herein, all remaining terms, conditions and provisions of the Agreement are unchanged and unaffected by this Renewal and Amendment No. 1 and shall continue in full force and effect as set forth in the Original Agreement.
- 2. A copy of this Renewal and Amendment No. 1 shall be attached to the Original Agreement.
