Adopt a resolution recognizing the **10th year anniversary of Mujeres en Acción.**

WHEREAS, Mujeres en Acción is an organization dedicated to creating opportunities for women to develop their leadership and economic self-sufficiency for a better life for themselves and their families; and

WHEREAS, Mujeres en Accion's mission is to help women gain access to the education, training, and support services they need to obtain better wages and jobs with potential for advancement, focusing on women who are motivated and participate to improve the economic security of their families; and

WHEREAS, Mujeres en Accion is designed as a mutual support approach for women to achieve personal goals and develop their leadership skills through weekly training and mentoring meetings; and

WHEREAS, compassion, equity, trust, integrity, and respect are values that **Mujeres en Acción** embody; and

WHEREAS, on February 7, 2026, the 10th anniversary of **Mujeres en Acción** was celebrated together with the Adelante Con Orgullo Mujer Inmigrante, ACOMI Conference, bringing the community together in a space for gathering, learning, and commitment; and

WHEREAS, this event brought together 220 people, including women and their families, and included more than 20 resource tables and 6 workshops focused on health, economic self-sufficiency, and leadership development, and also included the support of volunteers, organizations, and community leaders, reflecting its impact on the community; and

WHEREAS, at the conference, organizations and leaders were honored whose support has been fundamental throughout these 10 years of service of **Mujeres en Acción**; and

WHEREAS, over the past 10 years, **Mujeres en Acción** has strengthened the leadership, economic self-sufficiency, and the well-being of women, their families, and the community.

NOW, THEREFORE, BE IT RESOLVED, that the County of Monterey Board of Supervisors, on behalf of the County and all residents thereof, hereby recognize and celebrate the **“10th anniversary of Mujeres en Acción”**, highlighting its continuous commitment to accompanying women and its valuable contribution to the development of a more equitable, strong, and inclusive community in this event.
