**WHEREAS,** Government Code Section 61029.5(a) designates the Monterey County Board of Supervisors (BOS) as the Board of Directors (BOD) of the EGCSD, until conversion to a directly elected board of directors;

**WHEREAS,** LAFCO Resolution No. 05-20 states "No property tax revenues will be transferred from the County of Monterey, or any other agency, to the District as a result of this action";

WHEREAS, the July 18, 2006, Urban Services Agreement between the parties includes a provision that permits East Garrison to proceed in a manner that does not have a negative fiscal impact on the County;

**WHEREAS**, on August 29, 2017, an election was held to meet requirement of an election ten (10) years after formation with 498 registered voters and failed to have a directly elected BOD;

**WHEREAS,** on July 23, 2020, the Registrar of Voters certified in writing that the number of voters within the EGCSD reached or exceeded 500 voters;

**WHEREAS**, on January 13, 2001, County Counsel determined a May 2021 election date created legal inconsistences and therefore, on January 26, 2021, the election was cancelled;

**WHEREAS**, on February 25, 2021, County Counsel determined County is justified in charging EGCSD ED staff cost for preparing the cancelled special election;

WHEREAS, the Elections Department provided invoice for staff costs in the amount of \$5,019.46;

**WHEREAS**, the Department of Public Works, Facilities, & Parks processed payment to ED via Internal Exchange Transaction (IET) in accordance to BOD Resolution No. 20-307;

**WHEREAS,** on May 13, 2021, EGCSD Advisory Committee Chair submitted formal request for County to reimburse EGCSD in the amount of \$5,019.46;

**WHEREAS,** GFC budget has sufficient appropriations available to transfer funds to EGCSD in the amount of \$5,019.46;

**NOW, THEREFORE,** the Monterey County Board of Supervisors hereby resolves to approve the following:

- 4. Authorizes and directs the Auditor-Controller to transfer \$5,019.46 from General Fund Other Financing Uses, Appropriation Unit CAO017 to the EGCSD Fund 181, Appropriation Unit PFP006.
