Supervisor Chris Lopez recognized Captain Kelly Cardoza who retired from CHP after serving our area to end her career. He was able to get out there and see her final sign-off and present her with a certificate which was a very emotional day for her. She had a lot of family in town. He wanted, to thank, her publicly for her contributions to Monterey County especially as we look at that South of Salinas project. She was helpful with getting us information on collisions from CHP. The other item was the NMC Family Medicine Residency graduation. He made it out there to the Marriott, last Thursday, to recognize those folks who continue to serve our community through their efforts at the hospital. He hadn't heard their stories and the paths that they took. One of them had already been a lawyer and he was all set and then decided no, I'm going to go into medicine. He was from Madison, Wisconsin and turned his whole life around and ended up in Salinas as a doctor now. It was very inspiring, and he wanted to make sure our Board knew about those wonderful stories coming out of NMC. Lastly, Fourth of July was an awesome one in the Third District. He spent the day in Spreckels, Gonzales, Soledad, King City and Greenfield attending different events throughout the district. It was incredible to see the community turn out and to see folks so excited to spend time as a community.
