Adopt Resolution recognizing **Eden Valley Care Center** as a Monterey County Environmental Health Bureau Annual Food Safety Conference recipient of the Award of Excellence for 2018.....)

**WHEREAS**, each year the Monterey County Health Department, Environmental Health Bureau recognizes Monterey County food establishments with the Award of Excellence at the Annual Food safety conference; and

**WHEREAS**, “Working Together for Food Safety” is the mission of the Monterey County Health Department, Environmental Health Bureau, and the Monterey County Food Safety Advisory Council; and

**WHEREAS**, the Monterey County Health Department, Environmental Health Bureau, has worked with the Food Safety Advisory Council to create the Monterey County “Gold Seal” award as a symbol of a food facility’s commitment to attaining substantial compliance with the California Retail Food Code (Cal Code) for safe food handling and preparation; and

**WHEREAS**, the **Eden Valley Care Center** has endeavored to earn the Monterey County Health Department, Environmental Health Bureau “Gold Seal” award as a symbol of the food facility’s commitment to attaining substantial compliance with the California Retail Food Code (Cal Code) for safe food handling and preparation, including substantial compliance with food holding temperatures, cooking temperatures, receiving no more than five inspection violations and no major violations as listed on the inspection report; and

**WHEREAS**, the **Eden Valley Care Center** exemplifies the highest standards of Food Safety in their profession, promotes Food Safety, demonstrates a model commitment to sustainability of food safety practices, is a positive role model of food safety and has been active without major violations for at least five calendar years at the time of nomination; and

**WHEREAS**, the **Eden Valley Care Center** uses creativity and ingenuity to achieve compliant workers in food safety, promotes employee development and diversity, has demonstrated a high level of customer satisfaction and service, has proven an interest in the welfare of the community by incorporating managerial control for food safety, has had no major violations during the period of eligibility and has had no more than five Minor violations during any single inspection of the last three regular inspections; and

**WHEREAS**, **Eden Valley Care Center** strives to maintain a commitment to serving safe food; to heighten awareness and importance of food safety education; and to encourage additional food safety training for all employees.
