WHEREAS, the EDA Tech Hubs Program will support the modernization of United States manufacturing and improve commercialization and domestic production of innovative research; and

**WHEREAS**, the EDA Tech Hubs program is intended to advance the capacities of places to commercialize, deploy, and domestically manufacture and deliver these technologies; and

**WHEREAS**, the EDA requires the participation of State, territorial, local, or Tribal governments in order for the consortium to be eligible to apply for grants under both phases of the Tech Hubs; and

**WHEREAS**, the EDA will evaluate the consortium based on the quality of the partnerships and the relevance of the members to the consortium's strategy, rather than on the quantity of participating members; and

**WHEREAS**, the EDA Tech Hubs program may require the County to participate in future economic stimulus and tax incentive measures; and

**WHEREAS**, this EDA Tech Hubs requires the County to register with the EDA proposal portal, register in the Official U.S. Government System for Contract Opportunities (Sam.gov), and provide a valid unique entity identifier (UEI) in the grant application; and

**NOW, THEREFORE**, BE IT RESOLVED THAT the Board of Supervisors, in and for the County of Monterey, hereby:

Authorize the County Administrative Officer or Designee to join the consortium led by UCSC to submit a proposal for the EDA Tech Hubs grant. (4/5<sup>th</sup> vote required)
