Adopt Resolution commending **Chief Deputy Jeffrey J. Budd**, Monterey County Sheriff's Office upon his retirement from 34.5 years of Public Service

**WHEREAS, Chief Deputy Jeffrey J. Budd** was born and raised in Meriden, Connecticut. He served three years with the United States Army as a military policeman at Fort Ord, California. After graduating from the Gavilan Police Academy, he attended Hartnell College and graduated 1987 with an Associate of Arts Degree in Administration of Justice with an emphasis in Corrections and also graduated from the FBI National Academy in 2006; and

**WHEREAS, Chief Deputy Budd** was sworn in on April 4, 1978 by Sheriff William A. "Jack" Davenport. Over his career he served six Monterey County Sheriffs: William A. "Jack" Davenport, D.B "Bud" Cook, Norm Hicks, Gordon Sonn , Mike Kanalakis, and Scott Miller; and

**WHEREAS, Chief Deputy Budd** performed exceptionally as a 911 Emergency Operator, an Elections Field Inspector, Deputy Sheriff, Field Training Officer, Correctional Sergeant, Classification Sergeant, Administrative Sergeant, Courts Services Sergeant, Sheriff's Commander, and Chief Deputy; and

**WHEREAS, Chief Deputy Budd** was promoted to Field Training Officer on 03-08-83, Sergeant on 03-15-84, Commander on 12-15-2001, Chief Deputy on 12-31-10 and retires as the Chief Deputy of the Custody Operations Bureau; and

**WHEREAS, Chief Deputy Budd** was elected by his peers to four terms as the Secretary/Vice President of the Monterey County Deputy Sheriff's Association, and seven terms as the Secretary/Board of Director of the Monterey County Peace Officer's Association; and

**WHEREAS, Chief Deputy Budd** was awarded an Award of Merit from the Monterey County Peace Officers Association, a U.S. Army Commendation Medal, and selected as Deputy of the Month in 1996; and

**WHEREAS, Chief Deputy Budd**, over his long and distinguished career received numerous commendations from citizens and staff. Numerous community organizations and law enforcement agencies have praised Chief Deputy Budd for his exceptional work ethic, team work, and community commitment.

**NOW, THEREFORE BE IT RESOLVED**, that the Board of Supervisors of the County of Monterey on behalf of all people thereof, acknowledges, commends, and thanks **Chief Deputy Jeffrey J.
