

**RENEWAL AND AMENDMENT #1 TO AGREEMENT BY AND
BETWEEN
COUNTY OF MONTEREY & Milestone Communications, Inc., dba
Monterey County Weekly**

THIS AMENDMENT No. 1 is made to the STANDARD AGREEMENT between **Milestone Communications, Inc., dba Monterey County Weekly**, hereinafter “CONTRACTOR”, and the County of Monterey, a political subdivision of the State of California, hereinafter referred to as “County”.

WHEREAS, the County and CONTRACTOR entered into an AGREEMENT for design, printing, and publishing services with a term of August 5, 2024 through October 1, 2024 for a contract amount of \$40,949; and,

WHEREAS, the AGREEMENT expired by its terms on October 1, 2024; and

WHEREAS, the County and CONTRACTOR mutually wish to reinstate the AGREEMENT with an effective date retroactive to October 1, 2024, extending the term by eight (8) additional months through June 30, 2025; and increasing the contract amount by \$2,822 for a revised not to exceed amount of \$43,771.

NOW THEREFORE, the County and CONTRACTOR hereby agree to amend the AGREEMENT in the following manner:

1. **Paragraph 2, “PAYMENT PROVISIONS”, shall be amended by removing** “The total amount payable by County to CONTRACTOR under this agreement shall not exceed the sum of **\$40,949**” and replacing it with “The total amount payable by County to CONTRACTOR under this agreement shall not exceed the sum of **\$43,771.**”
2. **Paragraph 3, “TERM OF AGREEMENT”, shall be amended by removing** “The term of this Agreement is from August 5, 2024 to October 1, 2024, unless sooner terminated pursuant to the terms of this Agreement”, **and replacing it with** “The term of this Agreement is from August 5, 2024 to June 30, 2025, unless sooner terminated pursuant to the terms of this Agreement”.
3. Except as provided herein, all remaining terms, conditions and provisions of the AGREEMENT are unchanged and unaffected by this AMENDMENT and shall continue in full force and effect as set forth in the AGREEMENT.
4. A copy of this AMENDMENT 1 shall be attached to the original AGREEMENT respectively.
