RENEWAL AND AMENDMENT NO. 2 TO MASTER SERVICES AGREEMENT AND GROUP PURCHASING PROGRAM STATEMENT OF WORK BY BETWEEN VIZIENT INC. AND THE COUNTY OF MONTEREY ON BEHALF OF NATIVIDAD MEDICAL CENTER FOR PARTICIPATION IN THE GROUP PURCHASING ORGANIZATION (GPO) PROGRAM

This Renewal and Amendment No. 2 to the Master Services Agreement ("Agreement") which was effective on July 1, 2019 is entered into by and between the County of Monterey, on behalf of Natividad Medical Center ("Member"), and Vizient, Inc. ("Vizient"); collectively, Member and Vizient are referred to as the "Parties" to this Agreement, with respect to the following:

RECITALS

WHEREAS, the Agreement and a Group Purchasing Program Statement of Work between the Parties, dated July 1, 2019 ("GPO SOW") was executed by the Parties to permit Natividad Medical Center to participate in Vizient's Group Purchasing Program (the "Program"); and

WHEREAS, the Parties amended the Agreement and the GPO SOW via Amendment No. 1 to extend the Member's participation in the Program for an additional three (3) year period through June 30, 2025 for a revised term of Agreement (July 1, 2019 through June 30, 2025); and

WHEREAS, the Agreement expired on June 30, 2025; and

WHEREAS, the Parties currently wish to renew and amend the Agreement and the GPO SOW via this Renewal and Amendment No. 2 for an additional one (1) year period through June 30, 2026 for a revised term of Agreement (July 1, 2019 through June 30, 2026) to extend the Member's participation in the Program.

AGREEMENT

NOW, THEREFORE, the Parties agree to amend the Agreement as follows:

The Agreement and GPO SOW is hereby renewed on the terms and conditions as set forth in the Original Agreement, and in Amendment No. 1, incorporated herein by this reference, except as specifically set forth below.

The Agreement and the GPO SOW is hereby amended on the terms and conditions as set forth below:

- 1. Section 5.1 of the Agreement, "Term" of the Agreement is hereby deleted in its entirety and replaced with the following:
 - "5.1 Term. The term of this Master Agreement is from July 1, 2019 through June 30, 2026. In the event the term of any SOW extends beyond the Term of this Master Agreement, the Term of this Master Agreement will automatically extend to the latest expiration or terminate date of such SOW."

- 2. Section 3.1 of the GPO SOW, "Term" is hereby deleted in its entirety and replaced with the following:
 - "3.1 Term. The initial term of this SOW is from July 1, 2019 through June 30, 2026."
- 3. The following is added to the table in Section 5.2 of the GPO SOW:

Contract Year	Committed Purchases Requirement
July 1, 2025 – June 30, 2026	\$26,886,000

- 4. Except as provided herein, all remaining terms, conditions and provisions of the Agreement and the GPO SOW are unchanged and unaffected by this Renewal and Amendment No. 2.
- 5. A copy of this Renewal and Amendment No. 2 shall be attached to the Agreement.
- 6. This Renewal and Amendment No. 2 shall be effective on June 30, 2025 (the "Effective Date"). The Parties acknowledge and agree that in the event that either Party executes this Agreement at a date later than the Effective Date, the Agreement shall nonetheless be deemed effective retroactively to the Effective Date.
