Supervisor Jane Parker had a couple of announcements, first on a town hall meeting that Supervisor Adams and she are having at the Community Foundation with the office of Mark Stone that they are all co-sponsoring co-hosting tomorrow evening at the Community Foundation for Monterey

County from 5:00 to 7:00 p.m.; this will be a an update on the HEAP funding and the homeless shelter locations on the Monterey Peninsula as we know the state has approved about 12.5 million dollars that will be coming to our general area and local projects are beginning to take shape and the one that is being focused on is the potential locations for a homeless shelter on the Monterey Peninsula; it would be an update from various providers on the possibilities on the Monterey Peninsula also an update on the HEAP process and timeline and a way for people to be involved in making sure that the solutions that they think are most important can be part of that process so that is tomorrow evening from 5:00 to 7:00 p.m. at the Community Foundation there are some flyers about that up front here if people want a piece of paper to remind them; also new dates for hot topics are posted on her website and they're a great place to have a once-a-month get together on informal conversation about issues that are on the agenda for Board of Supervisors meetings but also more broadly affecting the County she invited anyone and everyone who's interested to join her; she also will be joining the community next Monday for the Annual Martin Luther King, Jr. Day of March and Day of Service in Seaside; the march will gather at the social services building on Broadway at Noche Buena and then they walk along Broadway and Fremont to the Oldemeyer Center where there will be speakers and if the previous years are to go by it will be an inspiring program; they will gather about 11:00 a.m. on Monday and the march starts at noon and she welcomed anyone to join.

Supervisor Luis A. Alejo announced news that just broke in the Washington Post that Monterey County was a lead plaintiff in a federal lawsuit challenging a citizenship question on the 2020 census and the federal district court judge ruled in our favor Monterey County and San Francisco County were the only two counties in California that were plaintiffs along with the US Conference of Mayors, several attorney generals this was a huge victory for us and for our immigrant population here in Monterey County; as you know when those types of questions that are untested it deters people from participating even if you are not undocumented you might be a lawful permanent resident, a refugee, a DACA recipient so it even deters those other categories of immigrants them and their families in not wanting to participate so it hurts Monterey County from receiving federal hundreds of dollars in federal dollars over the next 10 years ago so it could have had major consequences it will more than likely be appealed but certainly a major victory and he was proud that the board was a leader in joining the lawsuit early on and were lead plaintiffs in that victory; next he mentioned commemorating Martin Luther King, Jr. day certainly it is a day on and not a day off; it is a day of service and to recommit ourselves to civil rights and social justice; he usually attends the Seaside march since 2009 but this year he will attend the Martin Luther Jr. Day march at the Methodist Church in Salinas; he thought it was only appropriate this time to try to support those efforts and hopes that it will grow into an annual event in Salinas as well and lastly he congratulated local Salinas boxing champion, Ruben Villa, who fought last Friday night on his first national TV premiere on Showtime boxing on cable and he was able to score a unanimous victory; he is a very talented young man and it is good to see our young people excel and be stellar in their athletics and their profession but also be a role model and an example to the young people here in Salinas and Monterey County.

Supervisor Mary L. Adams wanted to call everyone's attention the Whale Fest that is going to be taking place at Monterey Municipal Wharf on January 26th

and 27th; it is a wonderful opportunity of education also food and a lot of fun and activities that take place down on the wharf for those two days that's January 26th and 27th and then also wanted to say that tonight is the final listening session that is being spearheaded by Monterey Peninsula Water Management District for the public's input on what is feasible as far as whether or not we should be able to purchase the Cal Am water company so that's tonight the last one they had this will be number five and it's going to be at the Sunset Center in Carpenter Hall and it begins at 6:00 p.m. it goes from 6:00 to 7:30 p.m. so if you've not had an opportunity to let your voice be heard she really encourages all to come forward; it is a great representation at all the other areas and now this one is that the last one.

Supervisor Chris Lopez commented on all the wonderful rain that's filling the lakes in South County but he knows there's also some predictions of a atmospheric river coming here in the couple days and so he just encouraged everybody to sign up for Alert Monterey so regardless of where you are you'll get the information on your phone and to stay aware your surroundings out there.

Supervisor John M. Phillips commented that on Saturday he went out to the Prunedale Grange as the snip bus was there; they wanted him to come out there because he was going to write them a check but they did an amazing job; they work down there in South County but they had 41 animals 23 dogs and 18 cats that were spayed and neutered and on Sunday they had 53 feral cats that were spayed and neutered; there were about 250 emails that came in of people that couldn't get the service done; they were 16 volunteers which most of them came from Hollister over to help us out; Denise Garcia from the Prunedale area and was one of the leaders on it; after that he talked to the new executive director of Animal Friends Rescue and they're looking at how they can partner to even explore the greater opportunities; he also took a ride down remote part of Old Stage Road and in just less than a mile there were 10 large objects of mattresses, sofas and refrigerators strewn out there which has become a bigger problem; it's become a bigger problem which is one of the things they're focusing on so either way put it can be put on Public Works to go help out there or he'll send a crew out from Rancho Cielo that's nearby to pick it up and take it to it there dump; he knows we need to come up with a program as this is one of the biggest problems that his office gets calls on.
