

AMENDMENT #1 TO AGREEMENT

AMENDMENT #1 TO AGREEMENT BY AND BETWEEN COUNTY OF MONTEREY & COLE PRO MEDIA, LLC

THIS AMENDMENT is made to the AGREEMENT for on-camera media training and crisis management, etc., for the Monterey County Sheriff's Office, by and between **COLE PRO MEDIA, LLC**, hereinafter "CONTRACTOR", and the County of Monterey, a political subdivision of the State of California, hereinafter referred to as "County".

WHEREAS, the County and CONTRACTOR originally entered into this Agreement on January 15, 2020 with a Not to Exceed amount of \$90,000.00 and a term date ending January 14, 2022; and

WHEREAS, the County and CONTRACTOR wish to amend the AGREEMENT by adding \$60,000.00 for a new Not to Exceed amount of \$150,000.00 and extend the agreement by two (2) years with end date of January 14, 2024.

NOW THEREFORE, the County and CONTRACTOR hereby agree to amend the AGREEMENT in the following manner:

1. Section 2., "PAYMENT PROVISIONS" shall be amended by removing, *"The total amount payable by County to CONTRACTOR under this Agreement is not to exceed the sum of \$90,000.00"*, and replacing it with, *"The total amount payable by County to CONTRACTOR under this Agreement is not to exceed the sum of \$150,000.00."*
2. Section 3., "TERM OF AGREEMENT" shall be amended by removing, *"The term of this Agreement is from January 15, 2020 to January 14, 2022"* and replacing it with, *"The term of this Agreement is from January 15, 2020 to January 14, 2024."*
3. Except as provided herein, all remaining terms, conditions and provisions of the AGREEMENT are unchanged and unaffected by this AMENDMENT and shall continue in full force and effect as set forth in the AGREEMENT.
4. A copy of the AMENDMENT shall be attached to the original AGREEMENT executed by the County on January 15, 2020.
