**WHEREAS**, Amy Christey began her career by serving her country in the United States Army and Army reserves from 1988 to 2003; and

**WHEREAS**, Amy Christey started her first job in law enforcement with the Santa Cruz County Sheriff's Department, working her way up through the ranks, and;

**WHEREAS**, Amy Christey, after 20 years as Lieutenant, became the Chief of Police in Morro Bay in 2012; and

**WHEREAS**, Amy Christey was chosen in the summer of 2016 from a field of 50 candidates, and was the first full time Police Chief since 2012; and

**WHEREAS**, Amy Christey raised the department's morale and has been credited with hiring 10 new sworn officers and doubling the administrative staff, which has allowed for employees to receive more training and professional development; and

**WHEREAS**, Amy Christey has designated experts within the Pacific Grove Police Department, such as four officers in drug DUI enforcement and assembling a media team; and

**WHEREAS**, Amy Christey initiated accreditation through the Commission on Accreditation for Law Enforcement Agencies (CLEA), which aims to enhance law enforcement as a profession and allows for networking amongst departments; and

**WHEREAS**, Amy Christey began a robust community outreach program to further relationships between the Pacific Grove community and the Police Department; and

**WHEREAS**, Amy Christey worked tirelessly to improve the Pacific Grove Police Department and the City of Pacific Grove; and

**NOW, THEREFORE, BE IT RESOLVED THAT**, the Monterey County Board of Supervisors, on behalf of the County and all citizens thereof, hereby acknowledges Chief Amy Christey's dedicated service to the City of Pacific Grove, and wishes her and her family happiness and success.
