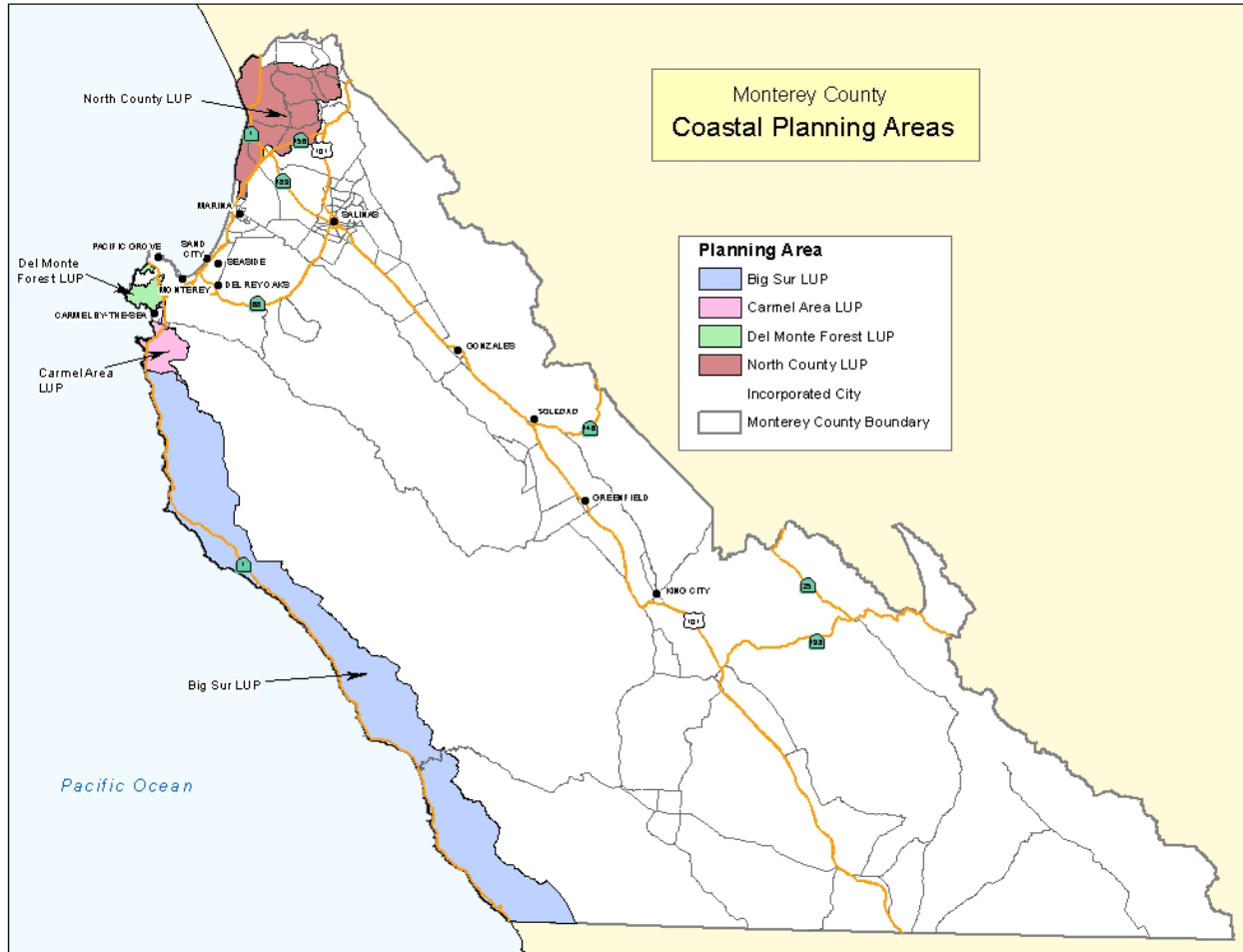

PLANNING AREA MAP

The proposed project involves four land use planning areas that comprise the approximately 310 square miles of coastal zone land covered by the Monterey County Local Coastal Program. Figure 1 shows the LCP planning areas.

PROJECT DESCRIPTION

Monterey County is requesting \$315,000 in grant funds to assist in the update of its Local Coastal Program. Of the requested funds, \$113,934 would be expended directly on technical studies and assistance, including:

- a maritime chaparral management plan,
- a visual resources analysis,
- an air quality and greenhouse gas emission analysis,
- a cultural resources analysis, and
- a regional sea level rise dialog and analysis regarding adaptation policies.

The remaining \$201,066 would be used to prepare key parts of LCP Part I (General Provisions), including a new safety element addressing climate change adaptation; to prepare plan documents for the Carmel and Big Sur planning areas; and to supplement public participation efforts in all planning areas.

The LCP Update would be 82 percent funded if these requested funds are awarded. Monterey County will be exploring other funding sources, including County funds, to secure the remaining 18 percent of needed funding. The following subsections describe the Monterey County Local Coastal Program (LCP) Update.

Goals and Objectives

The goal of the LCP Update is to undertake and complete a comprehensive update of the LCP to reflect changed circumstances and new scientific information, including new understandings and concern for the effects of climate change. Monterey County has identified five objectives related to the accomplishment of this goal:

1. Update each of Monterey County's four land use plans – *North County Land Use Plan*, *Del Monte Forest Land Use Plan*, *Carmel Land Use Plan*, and *Big Sur Land Use Plan* – to reflect changed conditions and new scientific or technical information and to respond to the Preliminary Periodic Review prepared by the California Coastal Commission in 2003. As detailed in the work program and budget presented in later sections, grant proceeds will fund document preparation by County staff and facilitate public outreach and coordination with California Coastal Commission staff.
2. Draft a new LCP Part I (General Provisions) to contain provisions that apply consistently across all land use plan areas. This objective will be accomplished by working with the appropriate established land use advisory committees and ad hoc committees to develop a draft document that will then be considered by the Planning Commission and Board of Supervisors. As detailed in the work program and budget presented in later sections,

grant proceeds will fund technical reports by outside experts in support of this new section as well as document preparation by County staff.

3. Update the corresponding Coastal Implementation Plans for each land use area to respond to new and revised policy contained in the four land use plans and the new LCP Part I (General Provisions). As detailed in the work program and budget presented in later sections, grant proceeds will fund document preparation by County staff.
4. Update the LCP to address climate change and sea level rise. This objective will build upon a collaborative regional effort currently underway with Moss Landing Marine Laboratories and Santa Cruz County jurisdictions to clearly define vulnerabilities of coastal development and resources from coastal and fluvial hazards and to investigate climate response strategies (i.e., adaptation, protection, retreat). This work is primarily funded by an Ocean Protection Council (OPC) Sea Level Rise Adaptation Grant awarded by OPC, the California Coastal Commission, and the State Coastal Conservancy in November 2013. Grant proceeds will fund a regional adaptation coordination process (workshop and policy meetings not funded by OPC grant) to coordinate policy development among jurisdictions and the preparation by County staff of a safety element that incorporates the information developed as part of the OPC Grant.
5. Prepare an appropriate document(s) to assess the environmental impacts of the LCP Update. This objective will be accomplished using existing staff resources, supplemented by the technical studies cited above.

Together, these five objectives will result in achieving the goal of comprehensively updating Monterey County's Local Coastal Program.

Project Details

This section discusses citizen participation, public benefit/significance, project need and extent, planning for climate change, likelihood of success, project support, workload, and project integration and matching funds.

Citizen Participation

The LCP Update includes a robust public participation program that includes meetings with three land use advisory committees, an ad hoc advisory committee, a regional climate adaptation committee (OPC grant) and the Monterey County Planning Commission, and the Monterey County Board of Supervisors. Additional outreach to other stakeholders and interested organizations will be undertaken dependent on staff resources and as appropriate to the topic. The public participation program also includes expansion of a regional web portal (www.centerforoceansolutions.org/montereybay.org) containing information on climate change and sea level rise as it affects the Monterey Bay Region. This public participation program helps

to ensure that Monterey County citizens are kept informed of, and invited to participate in, the LCP Update process, which is critical to developing broad public support for the effort.

The LCP Update will result in the comprehensive update of the Monterey County Local Coastal Program to reflect changed conditions and new scientific or technical information, with particular focus on responding to recommendations contained in the CCC's Preliminary Periodic Review from 2003 and incorporating policy guidance (including the draft guidance from the CCC) and regulation to address the affects of climate change and sea level rise. The LCP Update will affect approximately 90 miles of the 1,100 miles of California coastline (approximately eight percent) thereby making a significant contribution toward the CCC's goal of completing and updating LCPs statewide.

Public Benefit/Significance

Issues of Statewide Importance

This grant request is a companion to the Ocean Protection Council OPC Grant to study the effects of sea level rise and evaluate possible adaptation strategies. Results from the OPC Grant will support development of LCP responses to sea level rise and will serve as a model for similar work throughout coastal California. Monterey County is a regional partner in the Nature Conservancy's Statewide Climate Planning Team intended to support the exchange of ideas among the communities that receive OPC/LCP grant funding. The State policy discussions and prioritized actions will be highlighted at a LCP grant-sponsored symposium and agency brown bag discussions, with the intent to share adaptation approaches and aid in the establishment of standard approaches to addressing coastal threats in the 21st Century. Two coastal river inundation models developed for the OPC Grant project will also expand the amount of climate-change-related scientific and geospatial data that can be incorporated into the Northern Monterey County LCP and relayed to other areas of Monterey and the coast.

Public Benefits to the Coast

The LCP Update, in coordination with the OPC Grant, will provide a public benefit by allowing Monterey County to establish priorities and direct its limited funds to preserve and enhance coastal resources and protect land uses and critical infrastructure from the effects of climate change. A key element of this strategy would be to enable the use of natural infrastructure (i.e., coastal wetlands and natural lands) to mitigate the effects of sea level rise. The LCP Grant will support staff efforts to incorporate the technical information developed through the OPC Grant into the LCP Update.

Relative Need for LCP Update/Extent of Update

The Monterey County LCP currently consists of the four adopted land use plans – *North County Land Use Plan, Del Monte Forest Land Use Plan, Carmel Land Use Plan, and Big Sur Land Use Plan* – and their associated Coastal Implementation Plans, which are contained in Title 20 of the Monterey County Code. The LCP was originally certified and published in 1988, and while

there have been various minor amendments addressing specific issues, the program has not been comprehensively updated since its original publication. In 2003, the California Coastal Commission prepared a Preliminary Periodic Review that contains hundreds of pages of suggested revisions to the LCP. These recommendations addressed a wide range of pressing issues including: land use and infrastructure, natural habitats, water quality and marine resources, agricultural resources, public access and recreation, coastal hazards, scenic resources, and energy development.

The LCP update is a comprehensive revision to Monterey County's LCP and includes a proposed update and reorganization of the four existing land use plans and the creation of a separate Part I that addresses issues common to all coastal areas in the county. The intent is to eliminate redundancy and provide consistent policy language, as appropriate, between the four land use plans. For example, each of the four plans contain a definition of environmentally sensitive habitat areas (ESHA) that while generally having the same effect, are worded slightly differently. The update would eliminate the ESHA definition from each land use plan and create one definition in a new LCP Part I (General Provisions) that applies uniformly across all coastal areas. In addition the LCP Update will address inconsistencies and provide clarity within the individual land use plans.

As a whole, the LCP Update will result in a Local Coastal Program that more effectively preserves and protects coastal resources by:

1. Updating and streamlining coastal policy and implementation measures, with reference to the CCC Preliminary Periodic Review,
2. Building upon other work underway to adapt to sea level rise (see discussion below), and
3. Reorganizing program documents to improve clarity and user friendliness.

A detailed work program is presented in a later section.

Planning for Climate Change

In addition to addressing issues raised in the Preliminary Periodic Review, the LCP Update will address impacts related to climate change and sea level rise. This is an urgent effort, as associated impacts have already taken an economic and environmental toll on Monterey County. Important ocean research organizations, including the Monterey Bay Aquarium Research Institute and Moss Landing Marine Laboratories are planning significant investments in Moss Landing, where the effect of sea level rise could be felt acutely. New policy guidance will address shoreline protection, planned retreat, and redevelopment to ensure that existing and new development is accomplished in a safe and sustainable manner. Sea level rise may also result in higher levels of coastal erosion, which puts beaches, dune habitats, and valuable slough habitats like Elkhorn Slough at risk of degradation. New and or modified policy guidance is needed to

protect these important coastal resources. Finally, water resources, a critical issue in North Monterey County, are expected to degrade further as tides intrude further inland. As with the other impacts of climate change and sea level rise, this issue requires new and revised policy guidance.

As mentioned above, the LCP Update compliments ongoing work being undertaken regionally on climate change and sea level rise. Through the OPC Grant, Monterey County is collaborating with Moss Landing Marine Laboratories, Santa Cruz County, and the City of Capitola to undertake technical studies related to sea level rise adaptation. The work is tailored to evaluate and quantify the climate-related threats to urban, recreational, agricultural, and natural land uses using state-of-the-art hydraulic and climate models. The grant funds now being requested through this grant program will allow Monterey County to fully integrate important technical work into the LCP Update as new and retooled policy and regulation and to disseminate related information to planners and policymakers throughout the region.

Likelihood of Success/Effectiveness

The LCP Update actually began in 2008 with the initiation of the Moss Landing Community Plan Update. However, due to constrained staff resources and budget, the effort was suspended in 2010. With the award of the CIAP grant in 2011, the Moss Landing Community Plan Update was restarted in early 2012, and staff began work to scope the effort required to update each of the four Coastal Land Use Plans and Coastal Implementation Plan that comprise the Monterey County LCP.

The grant funds being requested from this program would enable Monterey County to complete work to update the Coastal Land Use and Coastal Implementation Plans and provide much needed budget support for the work being spearheaded by Moss Landing Marine Laboratories on climate adaptation.

The requested grant funds would help support the LCP Update public participation process by ensuring that Monterey County has the resources required to complete the lengthy and involved LCP update process. This will ensure that citizens are kept informed of, and involved in, the LCP Update process, which is critical to developing broad public support for the project. Grant proceeds will also ensure that Monterey County has the resources needed to coordinate effectively with agency staff at the California Coastal Commission on the LCP Update.

In terms of overall budget, grant proceeds would make a major contribution to the success and effectiveness of the LCP Update by increasing the level of secure funding up to 82 percent. Monterey County will be working to secure the remaining 18 percent of needed funding in the coming fiscal year (FY 14-15) exploring a range of other funding sources, including County funds.

Project Support

Monterey County's FY 13-14 LCP Planning Grant application is supported by the Center for Ocean Solutions, Monterey Bay National Marine Sanctuary, and The Nature Conservancy. Letters of support from both of these organizations are attached as Exhibit A.

In addition, the climate adaptation work to be funded by the companion OPC Grant is supported by the following organizations:

Center for Ocean Solutions – Provides technical and policy guidance and aids in development of adaptation alternatives and supports Monterey Bay regional dialogue on coastal adaptation and hosts the climatechangemontreybay.org website.

Central Coast Wetlands Group at Moss Landing Marine Labs – a coastal research and policy group that will coordinate data compilation, Technical Advisory Committee and stakeholder participation and lead drafting of technical and adaptation strategy documents

City of Capitola – is working on a comprehensive update of their General Plan which will include results of this project in the drafting to their Local Coastal Plan and Local Hazard Mitigation Plan.

Coastal Conservation and Research – Non-profit that will support the County to administer the contract and subcontracts and ensure that products are complete on time and within budget.

Elkhorn Slough National Estuarine Research Reserve – will participate as a member of the TAC and support county efforts to define policy changes.

FEMA – will provide technical support in county efforts to update FEMA flood plain development guidelines and local hazard mitigation plans.

Monterey Bay National Marine Sanctuary – Supports effort and integrates this project with other climate planning efforts on the central coast. MBNMS will continue to host a biannual conference on climate change.

Monterey County IRWMP Climate TAC – encourages input from regional climate experts to provide technical and policy guidance to project team.

Monterey County Water Resources Agency – provides guidance on water control structure locations and alternative flood management strategies

Natural Capital Project – aids evaluation of economic value of adaptation strategies

ESA PWA – Provides technical modeling expertise mastered through previous coastal projects in Monterey Bay and elsewhere along the U.S. West Coast and aids in development and evaluation of adaptation alternatives.

Resource Conservation District of Monterey County – Provides technical guidance and aids in development of adaptation alternatives for agricultural lands.

County of Santa Cruz – supports the development of technical and strategy documents and the policy analysis efforts. Ensure incorporation of improved information necessary for permitting purposes and site specific analysis in mapped coastal flood hazard areas and on coastal bluffs and beaches into the Safety Element of the General Plan and LCP. Agencies within the County include the Department of Public Works, Planning Department and the Environmental Health.

The Nature Conservancy – Provides technical and policy guidance and aids in development and evaluation of adaptation alternatives and supports Monterey Bay regional dialogue on coastal adaptation and host the climatechangemontreybay.org website.

Workload and Permit Streamlining

Due to the growing number of policy issues resulting from changing circumstance and new information made available through scientific research (as outlined in part by the 2003 Preliminary Periodic Review), Monterey County has accrued a backlog of development permits either awaiting completion of the LCP update or that have been appealed directly to the California Coastal Commission. The request grant funds and the resulting LCP update would allow Monterey County to resolve some of the permit backlog and hopefully reduce the number the projects appealed to the California Coastal Commission. This efficiency will reduce costs for both Monterey County and the California Coastal Commission and provide for more consistent application of changing norms and standards as new development proposals come forward.

Project Integration and Matching Funds

While the LCP Planning Grant requires no matching funds, the LCP Update includes funds from several sources, including:

- \$387,986 grant from the Coastal Impact Assistance Program (CIAP) awarded through the US Fish and Wildlife Service in 2011 for conservation, protection, and restoration of coastal areas. These funds supported revisions to the *Del Monte Forest Land Use Plan* in response to the Pebble Beach Company project and are also supporting ongoing work by County staff to update the *Moss Landing Community Plan* and the *North County Land Use Plan*;
- \$352,070 from applicants participating in the update of the *Moss Landing Community Plan*; and
- \$75,000 grant from the Ocean Protection Council, the California Coastal Commission, and the Coastal Conservancy to undertake technical studies related to sea level rise adaptation.

In addition to these funds, Monterey County is working to secure an additional \$290,000 from other as-yet-to-be-identified sources, including possibly Monterey County funds, to complete funding for the project. The LCP Update includes approximately \$165,000 in in-kind contributions from Monterey County, which provides staff to prepare the updated documents,

implement the public participation program, prepare the environmental analysis, and coordinate with agency staff from the California Coastal Commission.

WORK PROGRAM AND SCHEDULE

Application Budget Information

Monterey County is requesting \$315,000 in grant funds to complete funding for its LCP Update. Project funding sources, including requested grant funds, matching funds, and in-kind services are detailed below.

In-Kind Services: \$227,014

In addition to the other funds being gathered for the LCP Update, Monterey County projects the need for approximately \$227,014 in in-kind services. This represents the estimated value of personnel and operating expenses that are assigned from the Monterey County Resources Management Agency to complete the project.

Budget Summary

This section presents the budget summary for the LCP Update. Of the \$315,000 requested, \$98,934 would be used for technical studies to support LCP policy revisions and \$15,000 would be used to facilitate a regional dialog on sea level rise adaptation. The remaining \$201,066 would be used to prepare key parts of LCP Part I (General Provisions), including a new safety element addressing climate change adaptation; to prepare plan documents for the Carmel and Big Sur planning areas; and to supplement public participation efforts in all planning areas.



WHEREAS, the California Coastal Commission, under the authority of the California Coastal Act, may provide financial assistance to support coastal planning and has approved a competitive grant program to provide such financial assistance for LCP planning; and

WHEREAS, the goal of the grant program is to develop new or updated LCPs in conformance with the California Coastal Act and to reflect current circumstances and new scientific information, including new understandings and concern for the effects of climate change, and

WHEREAS, grant proposals submitted under this grant program must complete land use plan and/or zoning work to either achieve submittal for certification of a Local Coastal Program (LCP) or an Area of Deferred Certification (ADC) or of an LCP Amendment to significantly update a certified LCP or LCP segments, including with special emphasis on effects of climate change and sea-level rise;

WHEREAS, County of Monterey has an LCP that was effectively certified in 1988 in conjunction with Monterey County's 1982 General Plan; and

WHEREAS, in 2000, Monterey County initiated a comprehensive update of the General Plan, including policies that would apply within the coastal areas; and

WHEREAS, in 2003 the Coastal Commission prepared a "Preliminary Periodic Review" that identified portions of the Monterey County LCP that should be amended/updated, considering the draft General Plan Update at that time; and

WHEREAS, Monterey County adopted a General Plan in 2010 that applies to the non-coastal areas only, which functionally retains the 1982 General Plan for application in the coastal areas; and

WHEREAS, the County of Monterey desires to pursue a project that would result in the completion and submittal for certification by the California Coastal Commission of an Amendment to update the LCP, including a General Plan for the coastal areas; and

WHEREAS, the County of Monterey commits to and agrees to fully support a planning effort intended to update a certified LCP pursuant to, and fully in conformity with, the provisions of the California Coastal Act, with full public participation and coordination with the Coastal Commission staff.
