- c) Appropriations are increased by \$20,000 in the Health Department Fiscal Year 2022-23 Adopted Budget (092-4000-8108-HEA010) to accommodate an operating transfer out to (001-4000-8109-HEA006), funded with available fund (4/5ths vote required);
- d) The Auditor-Controller is authorized and directed to transfer \$20,000 from (092-4000-8108-HEA010), which has sufficient appropriations available to cover the transfer; and
- e) The Auditor-Controller is authorized and directed to incorporate the approved budget modifications to the FY 2022-23 budget, and County Administrative Office to reflect these approved changes in the Fiscal Year 2022-23 Health Department Adopted Budgets (016-4000-8111-HEA009), (001-4000-8109-HEA006), and (092-4000-8108-HEA010).
