

**AMENDMENT NO. 2
TO THE
AGREEMENT
BETWEEN THE
COUNTY OF MONTEREY
AND
SENECA FAMILY OF AGENCIES**

This Amendment No. 2 to the Agreement is made and entered into by and between the County of Monterey, a political subdivision of the State of California, hereinafter referred to as “COUNTY,” and Seneca Family of Agencies, hereinafter referred to as “CONTRACTOR.”

WHEREAS, on July 1, 2013, the COUNTY entered into the Agreement with CONTRACTOR in an amount not to exceed \$450,000 for the provision of targeted case management (TCM) services to eligible Medi-Cal beneficiaries (see attached Agreement).

WHEREAS, Amendment No. 1 replaced Exhibit B, Business Associate Agreement with Exhibit B.1, Business Associate Agreement, revised 12/12/2014.

WHEREAS, the County and CONTRACTOR wish to amend the AGREEMENT to reflect the County’s exercise of the option to extend for one (1) additional year and to increase the total amount of the AGREEMENT due to the extended term.

NOW THEREFORE, both parties hereby agree to amend the Agreement as follows:

1. **Article V, “TERM OF AGREEMENT”, Section A, shall be amended by removing “The term of this Agreement shall be from July 1, 2013 through June 30, 2018, unless sooner terminated provided herein” and replacing it with “The term of this Agreement shall be from July 1, 2013 through June 30, 2019, unless sooner terminated provided herein”.**
2. **Article VII, “FISCAL PROVISIONS”, Section B, last sentence shall be amended by removing “The total amount of this Agreement shall not exceed \$450,000” and replacing it with “The total amount of this Agreement shall not exceed \$459,000”.**
3. All other terms and conditions of the Agreement remain unchanged and in full force. This Amendment No. 2 shall be attached to the Agreement and incorporated therein as if fully set forth in the Agreement.
