Authorize the Auditor-Controller to amend the FY 2022-23 adopted budget by increasing appropriations in the amount of \$189,829 in the Housing and Community Development General Fund 001, Housing Administration Unit HCD001, financed by a decrease in appropriations in the amount of \$189,829 in the HCD Community Development, Fund 001, Appropriation Unit HCD002(majority vote)

WHEREAS, the General Fund 001, Housing Administration Appropriation Unit HCD001 provides staff services to other non-General Fund Appropriation Units within HCD for reimbursable projects assigned to administrative staff; and

WHEREAS, the General Fund 001, Housing Administration Appropriation Unit HCD001 is projected to exceed its appropriation budget of \$3,993,238 by \$189,829, as a result of a decrease in County reimbursable work assigned to administrative staff due to staffing vacancies; and

WHEREAS, the General Fund 001, Community Development Appropriation Unit HCD002 is estimated to come in under appropriations by approximately \$871,550 and is able to provide the funding source for the anticipated appropriation overage; and

WHEREAS, a transfer of appropriations within the General Fund will allow Housing and Community Development to meet its contractual, salary and other financial obligations; and

WHEREAS, the Housing and Community Development's commitment to detailed monthly financial and budgetary analysis and forecasting that led to identifying these potential appropriation shortfalls supports the County of Monterey Strategic Initiatives related to Administration by demonstrating accountability and transparency.

NOW, THEREFORE, the Monterey County Board of Supervisors hereby resolves to approve the following:

Authorize the Auditor-Controller to increase the FY 2022-23 adopted budget appropriations in the amount of \$189,829 in the Housing and Community Development General Fund 001, Housing Administration Unit HCD001 (majority vote) Legistar File ID No. RES 23-091 Agenda Item No. 55
