Awarded Job Order Contract Natividad Medical Center 2014-01 contract to California Plus Engineering Incorporated, (Agreement No. A-12670 & Construction No. 2015-011) the lowest responsible and responsive bidder for Natividad Medical Center Project JOC, with a bid award criteria figure of 1.1950, for a term of one year, with a minimum contract value of \$25,000 and maximum contract value of \$4.5 Million;
- b. Awarded Job Order Contract Natividad Medical Center 2014-02 contract to Ausonio Incorporated(Agreement No. A-12671 & Construction No. 2015-012), the lowest responsible and responsive bidder for Natividad Medical Center Project JOC, with a bid award criteria figure of 1.2060, for a term of one year, with a minimum contract value of \$25,000 and maximum contract value of \$4.5 Million;
- c. Awarded Job Order Contract Natividad Medical Center 2014-03 contract to John F. Otto, Inc. dba Otto Construction(Agreement No. A-12672 & Construction No. 2015-013), the lowest responsible and responsive bidder for Natividad Medical Center Project JOC, with a bid award criteria figure of 1.304, for a term of one year, with a minimum contract value of \$25,000 and maximum contract value of \$4.5 Million;
