A site walk-through was performed by this office on 20 December 2013. The objective being to clearly identify and define the work items completed to date and performed in conformance with the above referenced plans. They are as follows:

- 1) Clearing and Grubbing along Hidden Canyon Road from Sta. 52+25 to 64+00 (Complete).
- 2) Tree Removal from Sta. 52+25 to 64+00 (*Complete*). Currently undergoing tree removal from Sta. 64+00 to 67+00 Hidden Canyon Road and Sta. 10+00 to Sta. 11+00 along Cathrein Court.
- 3) Rough Grading/Earthwork Operations from Sta. 52+25 to 56+00 & 62+00 to 64+00 (*Complete and In Place*). Earthwork fill operations on-going and nearing completion in the sag from Sta. 56+00 to 62+00.
- 4) Storm Drain Line "A" (Complete and In-Place).
- 5) Erosion & Sediment Control Measures along Hidden Canyon Road from Sta. 52+25 to 64+00 (*Complete and In Place*). Erosion and Sediment Control BMP's (check dams, fiber rolls, silt fences, inlet protection & hydro-seeding) will continue to be monitored before, after and during any significant rainfall event.
