RECITALS:

WHEREAS, the Urban Areas Security Initiative (UASI) is a federal grant program administered by the Federal Emergency Management Agency (FEMA) that provides funding to enhance the ability of high-risk urban areas to prevent, protect against, respond to, and recover from acts of terrorism and other catastrophic incidents; and

WHEREAS, the City and County of San Francisco, serving as fiscal agent for the Bay Area UASI Approval Authority, has allocated \$74,173 for Fiscal Year 2024 UASI grant funds to the County of Monterey Department of Emergency Management, pursuant to a Memorandum of Understanding beginning on April 1, 2026; and

WHEREAS, these grant funds are allocated to purchase eligible equipment, designed to improve communication, interoperability, and resilience in Monterey County and its partner jurisdictions; and

WHEREAS, the Department of Emergency Management is required to designate officials authorized to execute grant applications, reimbursement requests, agreements, and all other documents necessary to implement and administer the UASI award.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Supervisors in and for the

County of Monterey as follows:

- a. Authorize the Department of Emergency Management to receive an award and execute Memorandum of Understanding (MOU) with the City and County of San Francisco to receive FY2024 Urban Areas Security Initiative (UASI) Grant Funds; and
- b. Approve and authorize the County of Monterey Department of Emergency Management to execute a Memorandum of Understanding with the City and County of San Francisco accepting a grant award of \$74,173 for procurement of equipment and implementation of the Fiscal Year 2024 Urban Areas Security Initiative grant for the grant performance period of April 1, 2026 through December 31, 2026; and
- c. Authorize the Director of Emergency Management, or designee, to carry out all grant-related activities, including submission of reimbursement requests.

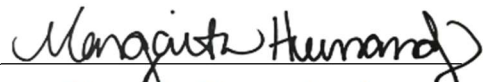
