**WHEREAS**, the Health Department requested to amend the Fiscal Year 2025-26 Adopted Budget 001-4000-8109-HEA006 to increase appropriations and estimated revenue by \$16,800, funded by the augmentation of grant subcontract revenues from the Public Health Institute (PHI): A collaborative program to address Substance Use Disorder (SUD) as a treatable emergency condition; and
