WHEREAS, Ordinance No. 05054 established procedures for the collection of delinquent fees and a lien transfer fee as special assessments constituting a lien on the property for the same of such delinquent fees; and

WHEREAS, it is desirable that past due assessments for sanitation service be collected; and

WHEREAS, the Board of Supervisors, acting as the Board of Directors of the Pajaro County Sanitation District, conducted a public hearing, heard the report, and considered any property owner protests and objections to the report to satisfy the requirements of Ordinance No. 05054 regarding procedures for collection of delinquent fees.
