- 3. Except as provided herein, all remaining terms, conditions and provisions of the Agreement and Amendment Nos.1 and 2, are unchanged and unaffected by this Amendment and shall continue in full force and effect as set forth in the Agreement.
- 4. A copy of this Amendment No. 3 and all previous amendments shall be attached to the original Agreement (No.MYA449).
- 5. The effective date of this Amendment is July 1, 2014.
