AMENDMENT NO. 2 TO SERVICES AGREEMENT BETWEEN LATITUDE GEOGRAPHICS GROUP LTD AND COUNTY OF MONTEREY, THROUGH ITS INFORMATION TECHNOLOGY DEPARTMENT FOR

SUPPORT AND MAINTENANCE OF THE COUNTY GIS DATA BASE AND APPLICATION

This Amendment No. 2 to the Services Agreement ("Agreement") which was effective on October 10, 2016 is entered into by and between the County of Monterey, on behalf of its Information Technology Department (hereinafter "COUNTY"), and Latitude Geographics Group LTD (hereinafter "CONTRACTOR"); (collectively, the County and CONTRACTOR are referred to as the "Parties"), with respect to the following:

RECITALS

WHEREAS, the Agreement was executed for CONTRACTOR to provide support and maintenance of the County GIS data base and application, with a term October 10, 2016 through October 9, 2019 and a total Agreement amount not to exceed \$75,000;

WHEREAS, COUNTY and CONTRACTOR amended the agreement to add Geocortex Virtual Classroom Training module, via Amendment No. 1, adding an additional \$25,000 for a total revised agreement amount of \$100,000 with no change to the agreement term; and

WHEREAS, COUNTY and CONTRACTOR currently wish to amend the Agreement, extending the term of the Agreement for an additional one (1) year period, for a revised term of October 10, 2016 through October 9, 2020, adding an additional \$3,763.79 for a revised not to exceed of \$103,763.79, with no change to the scope of services.

AGREEMENT

NOW, THEREFORE, the Parties agree to amend the Agreement as follows:

The Agreement is hereby amended on the terms and conditions as set forth in the Agreement, except as specifically set forth below.

- 1. Paragraph titled "TERM OF AGREEMENT", shall be amended to the following:
 "The term of this Agreement is from October 10, 2016 through October 9, 2020 unless sooner terminated pursuant to the terms of this Agreement."
- 2. Paragraph titled "PAYMENT PROVISIONS", second sentence, shall be amended to the following: "The total amount payable by County to CONTRACTOR under this Agreement shall not exceed the sum of \$103,763.79."
- 3. Except as provided herein, all remaining terms, conditions and provisions of the Agreement, as amended by Amendment No. 1, are unchanged and unaffected by this Amendment No. 2 and shall continue in full force and effect.
- 4. A copy of this Amendment No. 2 shall be attached to the Original Agreement.
- 5. This Amendment No. 2 shall be effective October 10, 2019.
